Description of Item(s) being offered as a donation to Alachua County:
Donation of a +/-14.52 acre parcel of land under the ownership of Smith Life Estate and Smith, identified as parcel number 18354-037-001 and located in Cross Creek on SE 171st Lane and abutting Orange Lake.

Donation(s) Offered by:

Joel E. Smith and Richmond G. Smith Nominated their property to the Alachua County Forever (ACF) Program as a fee simple donation.

On May 23rd, 2019 the Land Conservation Board (LCB) voted to move the property to their Priority Pool and recommend to the BoCC that the property be placed on the ACF Acquisition List.

Estimated/Appraised Value: \$32,900 ACPA Value

How Will The Donation(s) be Used?: This property will be an ACF conservation land that will contribute to the protection of water resources, wildlife habitat and natural communities in the Cross Creek area. It buffers Orange Lake and the surrounding conservation lands, in addition to being a part of a 100 plus acre area that Conserve Florida is working to protect in the Cross Creek area.

Will acceptance require the expenditure of County resources: Yes

Pre-acquisition costs include a phase 1 environmental site assessment, survey, and title insurance. A BoCC approved stewardship plan for the donated property will be developed, and the interim management costs will include invasive plant control and monitoring.

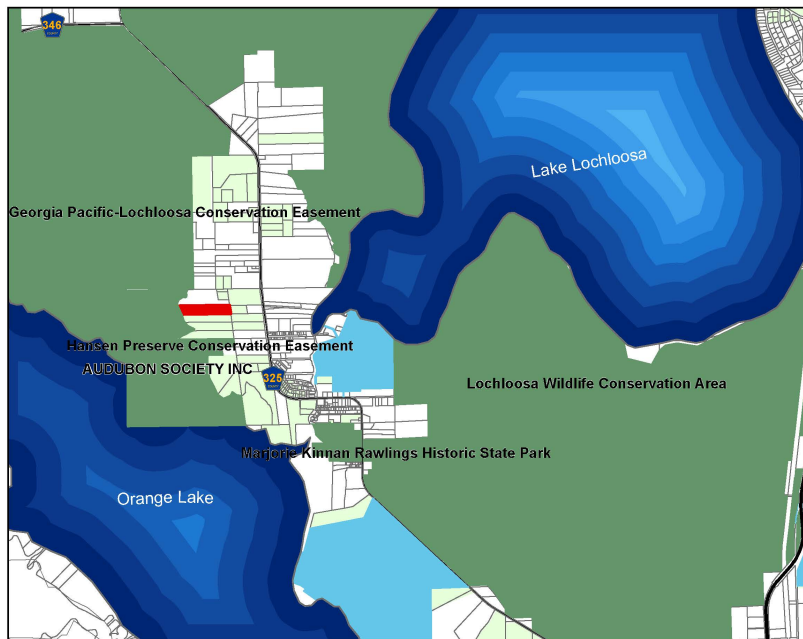

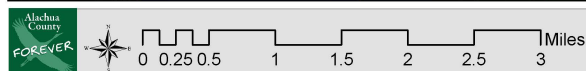
Lochloosa Forest Connector - Smith & Smith Location

Map 1



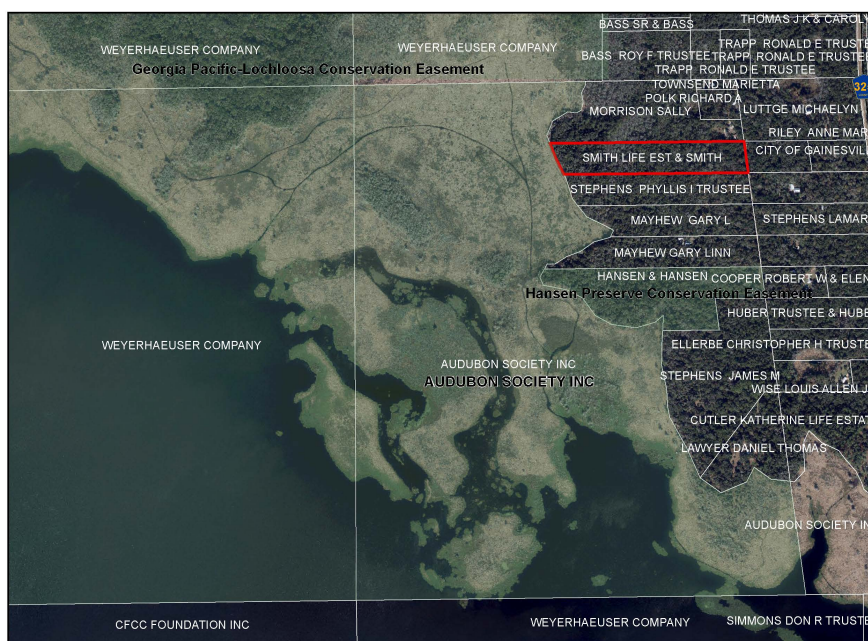

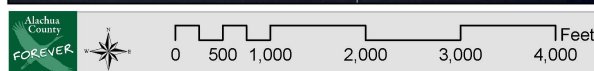
