

RESOLUTION 21-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, AMENDING THE FY2020-2021 ADOPTED BUDGET AND AUTHORIZED EXPENDITURES FROM THE FEDERAL MEDICAID CERTIFIED PUBLIC (CPE) EXPENDITURE PROGRAM; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the State of Florida has created a supplemental payment program for Medicaid managed care and fee for service patients who are transported to the hospital by public emergency medical transportation providers; and,

WHEREAS, on December 10, 2019, the Board authorized the Department of Fire Rescue to participate in the Intergovernmental Transfer with the State of Florida Agency for Health Care Administration and the Supplemental Payment Program for Medicaid Managed Care Patients and authorized the County Manager to execute all required agreements or documents to participate; and,

WHEREAS, on January 21, 2021, the Board amended the FY21 Adopted budget to recognize the revenue and expenditure appropriations associated with the 2020-2021 program; and,

WHEREAS, the County received the Emergency Medical Services Matching Grant for the purchase of three (3) automatic chest compression devices which requires a local match; and

WHEREAS, it is necessary to amend the FY2020-2021 Budget due to the grant award, required match, and redistribute funds for other purchases as approved by the Board; and

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

1. That the fiscal year 2020-2021 Adopted budget is hereby adjusted as reflected in the budget amendment attached hereto as Exhibit A.

2. By adoption of this resolution and the attached budget amendment, the Board of County Commissioners of Alachua County, Florida, hereby appropriates and permits the expenditure of the funds described therein.
3. That this resolution shall take effect immediately upon its adoption.
