My name is David Huelsman, I am the President and Head Coach for Gator Water Polo, Inc. We are a well established Gainesville based 501(c)(3) Non Profit Organization serving North Central Florida with a focus in Alachua County. We work very closely with Gator Swim Club and Robert Pinter. Our organizations serve the youth of Alachua County.

Robert Pinter is uniquely qualified to be a part of this project being a well-known swimming coach in the US, and former 1992 Olympian and Olympic finalist in Barcelona. Robert has been coaching from the Club to Professional levels for 20 years. He has most recently co-coached national Champion Ryan Lochte and six time World Champion Caeleb Dressel who, at the 2019 World Championships, won 6 gold medals, a silver and a bronze, the most in history. Caeleb also broke a World Record set by Michael Phelps in 2009 in the 100 butterfly at these championships.

I am also very well known in the swimming and water polo communities. I am the Co-Founder, President and Head Coach for Gator Water Polo, the only youth water polo program located in Gainesville. The program has grown from zero to serving over 100 youth athletes in Alachua County. I also have coached at every level, and am currently the Head Coach of the UF Men's Water Polo Team.

I am responsible for bringing the Florida International Water Polo Camp to Gainesville. The camp is top tier and brings in some of the best coaches in the world to work with our athletes, as well as athletes from around the world. We run this camp with The Barcelona International Water Polo Academy and The University of Florida. This camp is the largest of its kind on the east coast.

That being said, this opportunity was just recently brought to our attention and I know there is a vote scheduled in September to approve the sale of this property. Robert and I have worked on an extensive proposal for the Camp McConnell property to serve as a youth sports camp. We want to see the beauty of the natural landscape protected. If selected to negotiate we would largely agree to the terms of conservation for the majority of the land, and stipulations. We will also accept the property in an As-is state. We have put together a comprehensive plan for use of the camp, and would appreciate an opportunity

to negotiate. Our plan includes an initial investment of 2.17M dollars in repairs and improvements to make the property a premier aquatics camp facility. We also plan to put approximately 4.6M additional funds into the property over the next 10 years. Our organization is in a unique position to obtain the 2020 Olympic Trials Pool from Myrtha Pools to add to the notoriety of the facility. We plan to make this olympic pool the centerpiece of camp, on the site of the existing pool. The current pool is past restoration in a financially responsible manner. It would also be very difficult to program, due to its size and dimensions.

As a local aquatic sports organization, we want to provide services to residents of Alachua County, such as opening the facilities for Public Lap Swim and Tennis at cost, and camps for SBAC students at reduced rates. The proposal we are submitting also has the support of the Gainesville Sports Commission, and Joleen Cacciatore.

I am aware that there is currently an offer on the table with Friendship Circle. If at all possible, we would like to present our plan. We feel that with our connections to both Alachua County and SBAC, we can offer a great way to both conserve the land and use it as a Camp for the benefit of Alachua County Residents.

The initial seed money, 2.17M is coming from a generous benefactor in the form of a donation. We are ready to begin renovations upon closing. We would ask that due to the great benefit we will be bringing to the residents of Alachua County, we be allowed to schedule 10 payments once per year for a 10 year period, starting payback against the note in the 2021 year. With the property in such disarray, we need our upfront funding sources to attend to maintenance and repairs in order to commence operations.

Robert and I both plan on attending the August 27th regularly scheduled board meeting. We will address your group in person during the open comment period. Please let me know if it is possible to have conversations around this matter before then. We very much understand that time is of the essence.

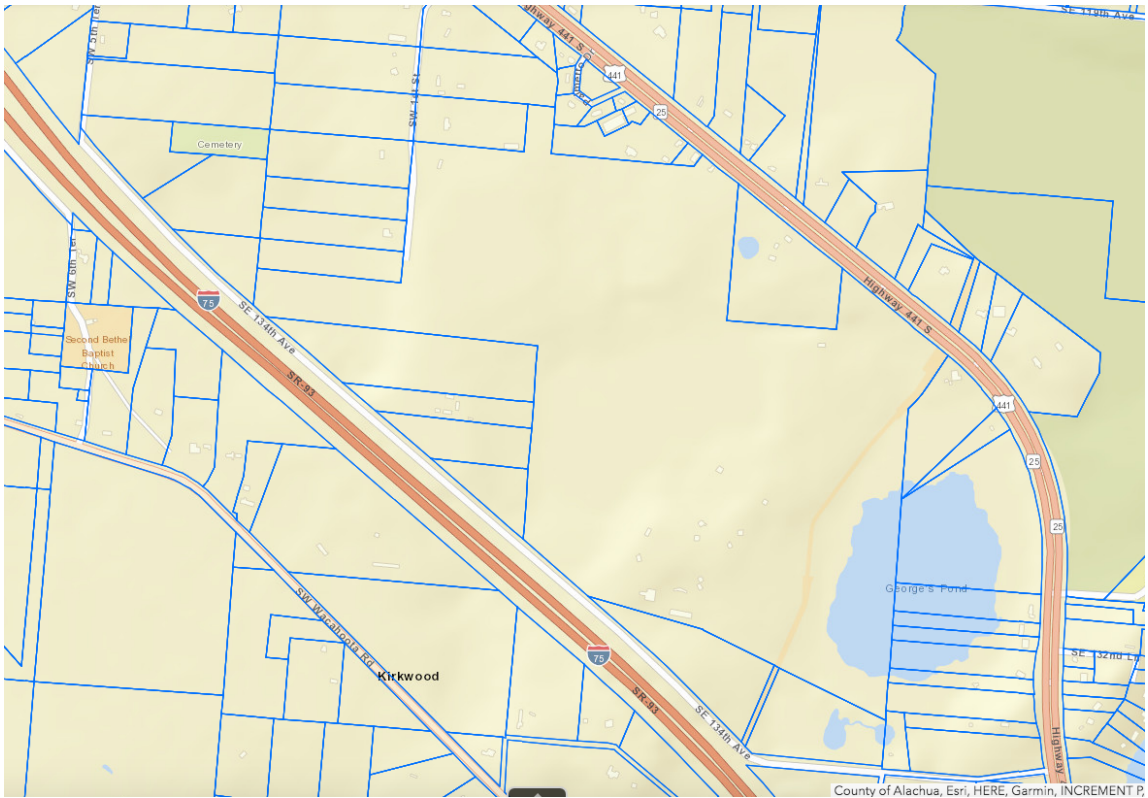
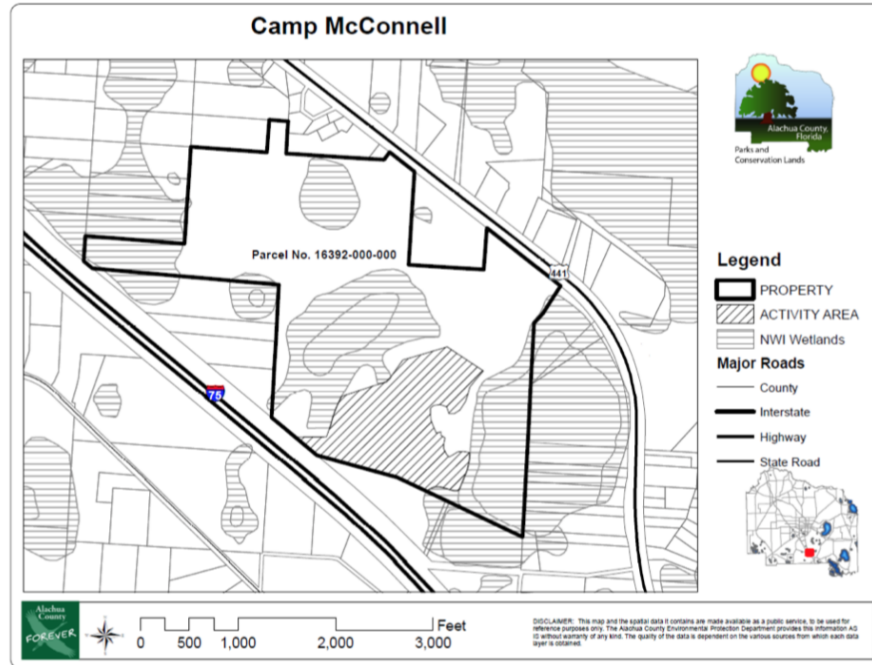
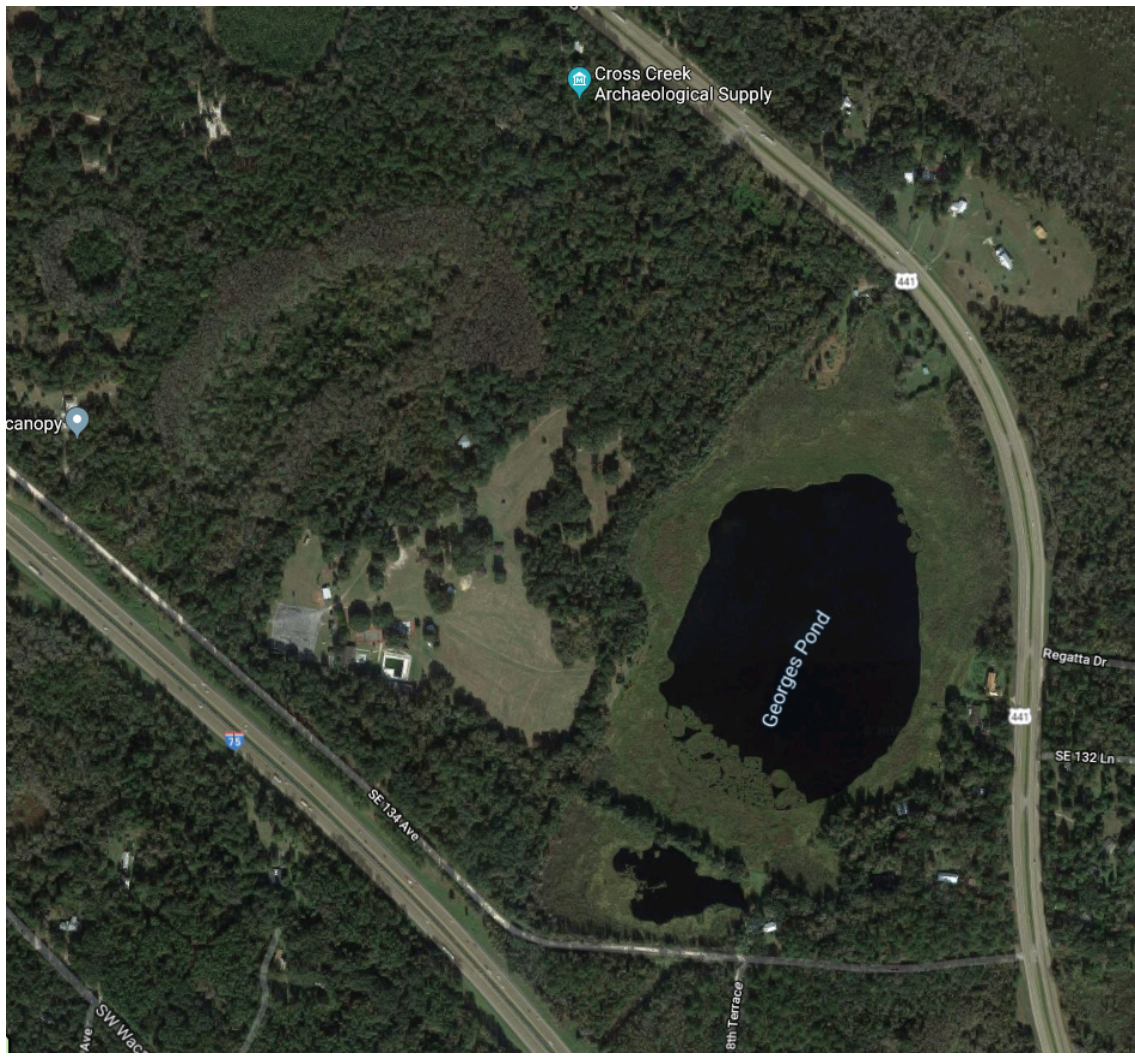


EXHIBIT "A-1" to COUNTY DEED
