- 1) We have distributed the AutoPulses to all Rescues. Crews should be familiarizing themselves with them and placing the soft stretchers underneath the platform folded for proper deployment. Crews on each rescue should be discussing where to place the AutoPulse on the on the truck and come to some agreement so it is not moved every shift. On Friday March 1<sup>st</sup> we will begin use of the devices, Shands and North Florida Regional emergency department personnel have seen the device, how it operates and have been told not to cut the band or the straps. They have also been told that Rescue Lieutenants will be close by to assist in operation of the device while also giving ED staff necessary patient information and been told that it is unknown how much battery life will be left when you arrive in the ED. There may be times that you may need to return to retrieve your AutoPulse at the hospital because of the need to respond to another call. AutoPulse has been added to Asystole/PEA Protocol and VFib/Pulseless Vtach Protocol.
- 2) The Lactate Scouts have also been distributed to the Rescues. Again, please come to a common agreement as to where they should be kept. The intervention for the Lactate Scout has been added to our patient care reporting software. Under "Comments" you will need to mark "Multiple Selection" "Research Analysis Only" and then the appropriate numerical reading That coincides with that indicated on the Lactate Scout.
