Amendment 105

This amendment (the “Amendment”) is made and entered into by and between Lutheran Services Florida, Inc. d/b/a LSF Health Systems, LLC (“LSF”) and Alachua County Board of County Commissioners (“Provider”) to be effective October 1, 2021. Provider and LSF may be referred to herein individually as a “party” or collectively as “the parties.”

Whereas, LSF wishes to amend the contract entered into between said parties on July 1, 2020, the purpose of this amendment is to modify contract language and increase funding.

NOW THEREFORE, in consideration of the mutual covenants, and the mutual promises contained hereinafter, and in exchange for good and valuable consideration, the sufficiency of which is hereby acknowledged by the parties, as independent contractors, the parties agree as follows:

1. Capitalized terms herein shall be ascribed the meaning given by the Contract. In the event of conflict between this Amendment and the Contract, this Amendment shall control.
2. Standard Contract, Paragraph 3, 'Payment for Services' is amended to: "contract of an amount not to exceed **\$2,188,025.00**, or the rate schedule, subject to the availability of funds" and is otherwise unchanged.
3. Standard Contract, Paragraph 23, 'Payment on Invoices' is amended to: "the Managing Entity has ten (10) working days to inspect and approve goods and services" and is otherwise unchanged.
4. Attachment I, Section C, Paragraph 1, 'Payment Clause' is amended to: "contract total dollar amount shall not exceed **\$2,188,025.00**, subject to the availability of funds from the Department" and is otherwise unchanged.
5. Exhibit H, 'Funding Detail' is replaced in its entirety with the Exhibit H, 'Funding Detail' revised October 1, 2021 incorporated herein. All prior references to same content are deleted. The terms outlined in this Exhibit shall be retroactive to July 1, 2021.

Except as amended herein, the terms and conditions of the Agreement remain the same in full effect and authority.

The parties' authorized representatives have executed this two-page Amendment to be effective this 1st day of October, 2021.
