A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA; AUTHORIZING ITS CHAIR TO MAKE, EXECUTE, AND SUBMIT APPLICATION TO THE STATE OF FLORIDA, DEPARTMENT OF ECONOMIC OPPORTUNITY A COMMUNITY DEVELOPMENT BLOCK GRANT CORONAVIRUS RELIEF FUNDING, AND ANY OTHER RELATED DOCUMENTS; AUTHORIZING THE SUBMISSION TO THE STATE OF FLORIDA, DEPARTMENT OF ECONOMIC OPPORTUNITY; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, AS FOLLOWS:

The Chair of the Board of County Commissioners of Alachua County, Florida ("Board") is authorized to make, sign, execute and submit a grant application to the State of Florida, Department of Economic Opportunity for the federal Community Development Block Grant – Coronavirus Relief Funding (CDBG-CV), and any other related additional documentation, certifications, authorizations, amendments and supplements. The Chair is further authorized, by way of this resolution, to execute, submit and deliver a CDBG-CV grant agreement between the Board and the Department of Economic Opportunity for the related project.
