**AMENDMENT TO AGREEMENT
BETWEEN ALACHUA COUNTY AND
PEERFIT, INC.**

THIS **First** AMENDMENT TO AGREEMENT made and entered into this 16th day October, 2019, by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and **Peerfit, Inc.**, hereinafter referred to as "Peerfit" Collectively hereinafter the County and Peerfit are referred to as the "Parties":

WITNESSETH:

WHEREAS, the Parties hereto previously entered into the **Enterprise Health Service Provider Agreement**. Dated **September 1, 2018** (the "Agreement"), for the provision of providing health and fitness opportunities to Alachua County Employees; and,

WHEREAS, the Parties wish to amend the Agreement to extend the term through September 30, 2020.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereby agree the amend the Agreement as follows:

A. Paragraph 3.1 of the Agreement, Term, is hereby amended in its entirety to read as follows:

3.1 Term.

3.1.1 This Agreement is effective upon execution and continue through September 30, 2020, unless earlier terminated as set forth herein.

3.1.2 This Agreement may be renewed for additional twelve (12) month terms by mutual written agreement of the Parties.

3.1.3 In the event a Party does not wish to renew the Agreement that Party shall give the other Party written notice of its intent not to renew this Agreement at least one (1) month prior to the end of the term.

3.1.4 Any changes to the terms of this Agreement to take effect during a Renewal Term must be mutually agreed upon in writing at least one (1) month prior to contract renewal.

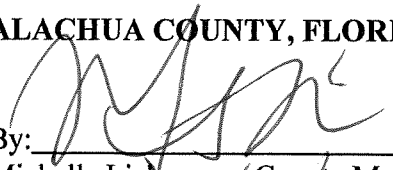
3.1.5 The County's performance and obligation to pay under the Agreement is contingent upon a specific annual appropriation by the Board of Client Commissioners. The parties hereto understand that the Agreement is not a commitment of future appropriations.

B. This First amendment shall take effect upon the date of execution by the Parties

SAVE and EXCEPT as expressly amended herein, all other terms and provisions of the original agreement between the Parties shall be and remain in full force and effect.

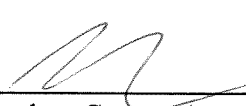

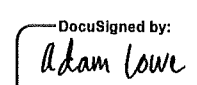

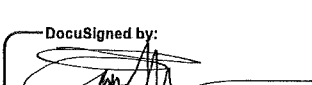
