## FIRST AMENDMENT TO AGREEMENT CONTRACTUAL SERVICES AGREEMENT BETWEEN ALACHUA COUNTY AND PUBLIC CONSULTING GROUP LLC FOR FLORIDA PEMT PROGRAM REQUIREMENT COMPLIANCE NO. 12024

THIS FIRST AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Public Consulting Group LLC, a Foreign Limited liability Corporation, which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

## WITNESSETH:

WHEREAS, the County and Contractor previously entered into Contractual Services Agreement dated for Florida PEMT Program Requirement Compliance dated May 20, 2021, identified by No. 12024 (the "Agreement"); and

**WHEREAS**, the Agreement was based on a Palm Beach County Request for Proposal, #19-020/SS and Agreement

WHEREAS, the Palm Beach County Agreement has been amended and renewed through August 19, 2024

**WHEREAS.** the Parties desires to amend the Agreement to extend the term to coincide with the Palm Beach County Agreement and to do as otherwise provided herein.

**NOW, THEREFORE.** the County and Contractor agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Section #1. of the Agreement titled "Term" 1 is amended to read as follows:
  - 1.1 The term of this Agreement is extended through August 19, 2024 unless earlier terminated as provided herein.
  - 1.2 The County's performance and obligation to pay under this Agreement is contingent upon a specific annual appropriation by the Alachua County Board of County Commissioners ("Board"). The Parties hereto understand that this Agreement is not a commitment of future appropriations. Therefore, the continuation of this Agreement beyond the end of any fiscal year shall be subject to both the appropriation and the availability of funds in accordance with Chapter 129, Florida Statutes, and that the failure of the Board to do so shall not constitute a breach or default of this Agreement.
- B. <u>Effective Date</u>. This Amendment is effective upon and after full execution by the Parties.
- C. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement,
