On April 12, 2022 the Alachua County Board of County Commissioners approved the creation of a Waste Reduction Grant program to be administered by the Solid Waste and Resource Recovery Department. The purpose of this grant is to create, or enhance, Waste Reduction activities by the non-governmental, non-profit and for-profit sector for the benefit of Alachua County. Grant proposals will be evaluated based on criteria including, but not limited to, the amount of solid waste diverted from the landfill, the ability of the Waste Reduction activities to continue when the grant is exhausted, and the activity's alignment with the County's Waste Reduction goals as approved in the County's Zero Waste Plan. The maximum award for a Waste Reduction Grant is \$40,000.00.

Recipients of a Waste Reduction Grant from Alachua County will be required to provide quarterly reports to Alachua County detailing the progress of the activities supported by the grant, the tons of waste diverted and a summary of the activities undertaken in support of the Waste Reduction activity proposed in this application.

PROVIDE A DETAILED DESCRIPTION OF THE WASTE REDUCTION ACTIVITIES FOR WHICH GRANT FUNDS ARE BEING REQUESTED.* Waste Reduction Activities Description

The project involves the acquisition of an Utility Terrain Vehicle (UTV) that will be driven by two employees with the goal of removing litter in the city of Gainesville and unincorporated Alachua County. The UTV we have chosen is the Kawasaki 2023 MULE SX. Kawasaki is a trusted brand that has been used successfully by Keep Brevard Beautiful for litter removal. The employees will set out four times each week to a different location each time and in rotation so that the areas remains clean. Those locations are a 4.85 mi section of Waldo Road, a 5.13 mi section of NE 53rd Ave, a 4.26 mi section of E University Ave, and a 4.23 mi section of NE 16th Ave. In total, we will be cleaning approximately 18.5 miles of road. Those roads are: NE Waldo Rd. from University Ave. to 63rd Ave.; NE 53rd Ave. from 34th Blvd. to Waldo Rd.; E University Ave. from Waldo Rd. to Newnans Lake; and NE 16th Ave. from Main St. to Waldo Rd.

We have chosen all the locations strategically close to the Leveda Brown Environmental Park and Transfer Station. We plan on storing the UTV at a shelter there while it is not in use. Thus, we have eliminated the need for a truck and trailer to haul the UTV from a distant storage location. Moreover, after the waste is picked up, the disposal will happen at the transfer station, too. Additionally, part of the safety and cleaning equipment for the employees has already been procured by us. Since we specialize in litter abatement, we already have much of the equipment on hand such as gloves, safety vests, first aid kits, and trash bags.

Staff and volunteers will record the amount of materials collected for both disposal and recycling for each segment of road on a daily basis. This will allow us to assess the impact of the UTV drivers and volunteers clean-up activities. We will also record the number of miles cleaned each day and the number of hours of work completed. Maintenance and fueling records for the UTV will also be kept.

Waste Reduction Activities Description

We estimate we can collect 16 bags weighing 25 pounds of solid waste each working day based on similar projects. On an annual basis, that accumulates to about 45 tons. The solid waste will be removed from our streets and roads and transferred to the Leveda Brown Environmental Park, where it can be disposed of in a more environmentally-conscious way. If the trash were not collected, the

trash would be filling our land and waterways in the worst possible way, in an uncontrolled landfill of sorts. These efforts will help to maintain the visual appeal of heavily trafficked areas as well as protect the nearby ecosystems from potentially harmful waste.

In addition to this roadside litter cleanup project, KACB is proposing to assemble a stakeholders task force under a separate grant that will address the heart of the issue by reducing the incidence of litter at the source: the people of Gainesville and Alachua County. This task force, a litter prevention strategy team, will improve waste reduction behaviors through enforcement of solid waste ordinances, and a litter prevention advertising campaign will target adults and youth to educate them on how their behaviors affect litter. The stakeholders will be recruited from state and municipal solid waste agencies, educational institutions, law enforcement agencies, the judiciary, tourism development agencies, businesses, chambers of commerce, and other interested members of the public. The task force activities and advertising campaign will be funded from other grants.

Additional Funding Detail

For the past 30 years, Keep Alachua County Beautiful has worked to educate, empower, and energize the local community in improving aesthetics and preserving the natural resources of Alachua County. KACB was established in 1991, and since then it has regularly received more than \$100,000 annually from public agencies (city, county, and state governments) and private foundations including UPS, Clay Electric, Weyerhaeuser, Lowe's, Altria, and Keep America Beautiful.

KACB has used these funds to support hundreds of community projects over the years. For example, KACB has established five community gardens through grant funding and continues to expand and maintain the gardens for the communities. Additionally, KACB utilizes a long-standing partnership with the South West Advocacy Group in order to implement an after-school environmental educational program for elementary school-aged children. KACB staff and volunteers also remove graffiti and litter on a daily basis, seven days each week. Beautification projects including tree planting, mural painting, invasive plant removal, and the restoration of cemeteries and other historical sites are completed on a weekly basis.

KACB has seen profound success with its prior litter cleanup efforts. Most notable is our signature Great American Cleanup event, the largest volunteer effort in Alachua County. The GAC is hosted all year long and brings together thousands of local community members to help eliminate litter, graffiti, and other blight. KACB has hosted the GAC for the past 29 years, where we have consistently engaged 3,000 to 5,000 volunteers annually. An annual cleanup and volunteer appreciation day is hosted annually for Gainesville and unincorporated Alachua County, and separately in each of the other municipalities in Alachua County, too.

From July 1, 2020 through June 30, 2021 alone, 3,003 KACB volunteers provided 15,648 hours of service. The volunteers collected 411,920 lbs. of litter for disposal. Nearly 6,000 pounds of bottles, cans, tires and yard trash were collected for recycling. Additionally, each semester KACB enlists the help of five to ten undergraduate and graduate interns from the University of Florida and Santa Fe College who work five to twenty hours each week to assist in the creation, implementation and continued support of KACB projects and interests. These staff and interns implement the following programs: a litter prevention social media and membership campaign; the Adopt A Road program; the Cigarette Litter Prevention Program; waterways cleanups; twice weekly "after hours" downtown summer cleanups; after-school environmental education at community centers; promotion of energy conservation, water conservation, proper household hazardous waste disposal, invasive species eradication, recycling, waste prevention, and more.

While no additional funding has been secured specifically for this grant, we intend to work with stakeholders such as the University of Florida, City of Gainesville, Florida Department of Transportation, U.S. and Florida Fish and Wildlife Commissions, Visit Gainesville, and Alachua County to secure additional funding. Additionally, with the more than \$100,000 awarded annually to KACB by public agencies (city, county, and state governments) and private foundations including UPS, Clay Electric, Weyerhaeuser, Lowe's, Altria, and Keep America Beautiful, KACB can leverage additional funds and materials necessary for the success of this project from other private foundations and sponsors..

PROVIDE A DETAILED RESPONSE TO HOW THESE SOLID WASTE REDUCTION ACTIVITIES ALIGNS WITH THE ALACHUA COUNTY ZERO WASTE PLAN.*

Waste Reduction Activities Description

The clean-up project aims to reduce and remove litter around the city of Gainesville and the unincorporated area of Alachua County that lies within the Municipal Service Taxing Unit. A team of two employees, operating a utility terrain vehicle, will set out four times each week into the more heavily-littered areas to pick up any and all litter they observe. Approximately five additional volunteers will be fielded weekly on foot in each of these four areas to clean up smaller bits of litter such as cigarette butts, broken glass, plastic straws, and bottle caps. The litter will be separated into different categories for recycling and disposal purposes, as per the outline of the Alachua County Zero Plan; the program will reduce the litter present on roadways and in waterways while recovering litter such as bottles and cans for sale to processors for eventual manufacture into new products. Landfill space will be conserved through these recycling efforts. As importantly, trash will be controlled from filling our land and waterways where it is an eyesore, polluting, and endangers both wildlife and humans. Furthermore, our hands-on litter removal activities engaging pedestrian volunteers creates and reinforces a strong waste reduction ethic for these volunteers and the general public when they witness the volunteers in action.

Two salaried maintenance drivers will clean the listed roads. They will also be tasked with disposal of the solid waste collected at the Alachua County transfer station and keeping records of the materials disposed and recycled. Our labor will consist of two workers at \$17 per hour. The workers will work four days each week for a 4-hour shift each, a salary of \$27,744. With FICA tax included, the personnel costs are \$29,866. The executive director, Gina Hawkins, will provide training, supervision and safety training. Her position is funded by separate litter prevention agreements with the City of Gainesville, Alachua County, and Keep America Beautiful.

2. Equipment = \$8,789

In order for our employees to collect litter in an efficient manner, the funds allocated to equipment will be used to provide them with an UTV plus the shipping and handling costs to deliver the equipment. The UTV we plan to purchase is the 2023 Kawasaki MULE SX, a vehicle designed to handle tough terrain. We plan to buy the 2023 Kawasaki MULE SX for \$7,799 plus shipping and handling costs of \$990.

3. Fuel Costs = \$1,064

Fuel was estimated at assuming the current average gas price of \$4.75 would continue into 2023. Approximately 20 miles would be driven every work day. and the average mileage of the MULE SX is 20 MPG. The fuel cost is estimated at \$1,064.

4. Additional Supplies & Miscellaneous Expenses = \$281

For refreshment of our workers, we plan to buy an Igloo Cooler to fill with water and ice so refillable bottles can be used by the workers. The workers will also need security vests, gloves, helmets, hand held grabbers, bags, buckets, first aid kits. The cleanup and safety supplies will be afforded by separate grants and sponsors and will be provided as matching support.

Our two maintenance employees will require vests, gloves, and first aid materials for safety, and trash bags for litter collection. These items will be provided by KACB. The remaining \$281 will be budgeted toward any potential repairs on the MULE, a water cooler, and any other training and safety materials and supplies that we may need.

5. Matching Funds and In Kind Support = \$52,146

Clean-up and safety supplies, volunteers, and indirect costs will be provided from existing public and private grant sources, and in kind support. Approximately \$26,000 in volunteer hours value, \$7,467 in safety training and administration, \$250 in supplies, and \$18,429 in indirect costs (overhead) for a total of \$52,146 in matching funds and in kind support.

UTV Roadside Cleanup Project Business Plan

Identity

KACB is a non-profit with a mission to beautify, conserve resources, recycle, educate and preserve our community's environmental legacy.

Our solution

As a pilot program, we propose an UTV Roadside Pickup program to clean up four roads near the Gainesville Regional Airport four times a week. We are also proposing a Litter Prevention Task Force, waste reduction advertising campaign, and an environmental education program. These two programs would be funded by separate grant awards from Alachua County.

The competition

We will be competing with non-governmental, non-profit, and for-profit organizations. We are confident the KACB record of community involvement on litter prevention, cleanup, recycling, and environmental education will make us stand out among our competition.

Problem

Streets and roads in Alachua County are littered with solid waste that has an adverse effect on its quality of life, aesthetics, and natural resources. Alachua County is looking for trustworthy non-profit organizations that specialize in waste management.

Target market

We will be submitting the grant to the Alachua County Board of Commissioners in response to a Request for Applications posted by Alachua County.

Revenue streams

KACB receives annual funding from the City of Gainesville, Alachua County, Keep America Beautiful, private foundations, businesses, and individuals to afford continued implementation of cleanup efforts including the insurance, supplies, administration, and indirect costs associated with our litter reduction and beautification efforts. Over \$100,000 has been awarded annually to KACB to implement these programs and all indications are that this funding will continue at this level. We will work to partner with stakeholders such as University of Florida, Florida Fish and Wildlife Conservation Commission, Visit Gainesville, and the Greater Gainesville Area Chamber of Commerce to receive additional funding from them

	to continue the program and complement the Alachua County and City of Gainesville grant funds allocated.

Attachment 1 – Project Boundary Map



The KACB UTV Roadside Cleanup Project will focus on roads adjacent or in close proximity to the Leveda Brown Environmental Park, and Gainesville Regional Airport. Specifically, it will include a 4.85 mi section of Waldo road, a 5.13 mi section of NE 53rd Ave, a 4.26 mi section of E University Ave, and a 4.23 mi section of NE 16th Ave. Below is an illustrated map with the road segments highlighted:

Basis of Estimates

<u>Staff Labor</u> - Our labor will consist of two workers at \$17 per hour. The workers will work four days each week for a 4-hour shift each, a salary of \$27,744. With FICA tax included, the personnel costs are \$29,866. The executive director, Gina Hawkins, will provide training, supervision and safety training. Her position is funded by separate litter prevention agreements with the City of Gainesville, Alachua County, and Keep America Beautiful.

<u>Fuel</u> - We will clean four roads around the Gainesville Regional Airport and NE Waldo area and in east Gainesville. Those roads are: NE Waldo Rd. from 39th Ave. to 63rd Ave., NE 53rd Ave. from Main St. to Waldo Rd., E University Ave. from 15th St. to Lake Shore Dr., and NE 16th Ave. from Main St. to Waldo Rd. We estimate that approximately 20 miles of driving will happen each workday. Assuming the cost of gas remains around \$4.75 and gas mileage is 20 MPG, then the fuel cost is estimated at \$1,064.

<u>Equipment Expenses</u> - We plan to buy the <u>2023 Kawasaki MULE SX</u> for \$7,799 plus shipping and handling costs of \$990.

<u>Materials and Supplies</u> - To refresh our workers, we plan on buying an Igloo <u>Cooler</u> to hold water and ice to allow the use of refillable bottles by the workers. The workers will also need security vests, gloves, helmets, hand held grabbers, bags, buckets, first aid kits. The cleanup and safety supplies will be afforded by separate grants and sponsors and will be provided as matching support.

<u>Matching Funds and In Kind Support</u> - Clean-up and safety supplies, volunteers, and indirect costs will be provided from existing public and private grant sources, and in kind support. Approximately \$26,000 in volunteer hours value, \$7,467 in safety training and administration, \$250 in supplies, and \$18,429 in indirect costs (overhead) for a total of \$52,146 in matching funds and in kind support.

KACB is a non-profit with a mission to beautify, conserve resources, recycle, educate and preserve our community's environmental legacy.

Our solution

As a pilot program, we propose an UTV Roadside Pickup program to clean up four roads near the Gainesville Regional Airport four times a week. We are also proposing a Litter Prevention Task Force, waste reduction advertising campaign, and an environmental education program. These two programs would be funded by separate grant awards from Alachua County.

The competition

We will be competing with non-governmental, non-profit, and for-profit organizations. We are confident the KACB record of community involvement on litter prevention, cleanup, recycling, and environmental education will make us stand out among our competition.

Problem

Streets and roads in Alachua County are littered with solid waste that has an adverse effect on its quality of life, aesthetics, and natural resources. Alachua County is looking for trustworthy non-profit organizations that specialize in waste management.

Target market

We will be submitting the grant to the Alachua County Board of Commissioners in response to a Request for Applications posted by Alachua County.

Revenue streams

KACB receives annual funding from the City of Gainesville, Alachua County, Keep America Beautiful, private foundations, businesses, and individuals to afford continued implementation of cleanup efforts including the insurance, supplies, administration, and indirect costs associated with our litter reduction and beautification efforts. Over \$100,000 has been awarded annually to KACB to implement these programs and all indications are that this funding will continue at this level. We will work to partner with stakeholders such as University of Florida, Florida Fish and Wildlife Conservation Commission, Visit Gainesville, and the Greater Gainesville Area Chamber of Commerce to receive additional funding from them

	to continue the program and complement the Alachua County and City of Gainesville grant funds allocated.
Marketing activities KACB utilizes social media, a website, newsletters, individual and group presentations, educational webinars and seminars, and advertising to promote litter prevention, litter cleanup, recycling, food and yard waste, composting, beautification, grafitti prevention, and invasive plant and animal eradication.
