

**AMENDMENT TO CONTRACT
FOR OPERATION OF THE ALACHUA COUNTY HEALTH DEPARTMENT
CONTRACT YEAR 2020-2021**

THIS AMENDMENT is entered by and between the State of Florida, Department of Health (“State”) and the Alachua County Board of County Commissioners (“County”), through their undersigned authorities (collectively the “Parties”).

WITNESSETH:

WHEREAS, a Contract Between Alachua County Board of County Commissioners and State of Florida Department of Health for Operation of the Alachua County Health Department, Contract Year 2020-2021, was executed on 9/22/2020 (“Operation Contract”); and

WHEREAS, attached to and incorporated in the Operation Contract was Attachment IV listing the facilities utilized by the County Health Department; and

WHEREAS, additional properties are anticipated or will be used by the State during Fiscal Year 2020-2021, resulting in the need for an amendment to the Operation Contract.

In consideration of the mutuality of the rents, covenants, agreements, terms, and conditions hereinafter contained, the Parties hereto do mutually covenant and agree as follows:

1. Recitals. The foregoing going recitals are true and correct.
2. Amendment. The Parties agree that Attachment IV attached to and incorporated to the Operation Contract listing the Facilities Utilized by the County Health Department for Fiscal Year 2020-2021, is hereby amended to delete reference to 6520 NW 18th Dr., Gainesville, FL and to add the following additional facilities:
