Alachua County CARES Act Update

- July 7 – Approved plan & use of CRI to administer
- Aug 3 – Approved amended plan and eligibility
 - Approved gov't allocations
- Aug 4 – Opened individual assistance program
- Aug 10 – Opened business assistance program
- Sept 1 – Increased caps for individuals & approved Aug & Sept reapps for both programs



Alachua County CARES Act Update

- Oct 6 – Approved nonprofit assistance program
- Nov 2 – Approved use of public safety salary and benefits presumption for remaining funds
- Dec 3 – FDEM deadline for all reimbursement requests to be submitted
- Dec 30 – FDEM deadline for spending
- Feb 28 – FDEM deadline for documentation

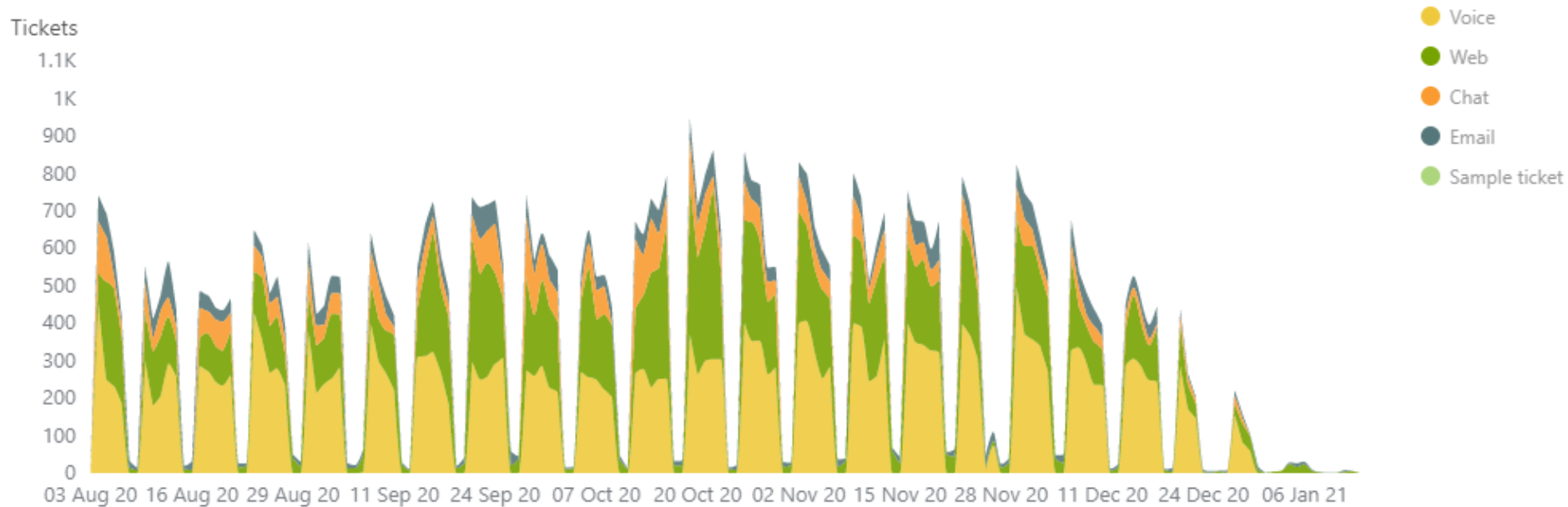
