Note from the Out-Going Chair: The Economic Development Committee continued to make progress on its workplan even in the ongoing disruption of the pandemic. COVID has continued to impact membership and attendance. The Board's recent revision to the membership requirement is hoped to fix this. - Monitor and provide recommendations to the development of the business and marketing plan of the Alachua County Eco-Industrial Park
- Encourage initiative to advance reliable and affordable internet infrastructure in Alachua County.
- Support the development of municipalities' bike/pedestrian plans and ecotourism for integration into a County-wide plan (Trail Towns)
- Monitor and provide input related to the new CRA funding allocated for East Gainesville and the City of Newberry
- Monitor and support Gainesville Regional Airport initiatives and determine if Alachua County can be of assistance in supporting their growth
- Promote the reuse/circular economy potential in Alachua County (added by BoCC in 2021) - This item will include a review of the business selection criteria

Standing Goals:

- Continue to encourage responsible east county development and provide recommendations to BoCC.
- Support initiatives to diversify local economy in targeted industries.
- Provide recommendations to the BoCC regarding economic development activities and projects at the Old Fairgrounds, Eco-Industrial Park, and East County development as needed.
- Provide recommendations, as necessary, to the BoCC related to QTI proposals;
 Florida Flex; future business development; grant funding; zoning; and, incentives zones.
- Committee will take a more public proactive role in the community in evaluating and advancing the County's competitiveness.
- Support regional workforce board and education training entities in training and retraining to prepare individuals for skilled employment. Support innovative programs such as Startup Quest and eWITS.
- Collaborate with state economic development agencies in promoting economic development in Alachua County.
- Extend invitation to smaller municipalities to participate in EDAC monthly meetings.
- Invite economic development stakeholders to attend one EDAC meeting to discuss alignment and economic development priorities in the community.

- Monitor, support as appropriate, engage, and provide input regarding the new Gainesville Chamber strategic plan and implementation
- Assist County Economic Development Coordinator in accomplishing goals and objectives of EDAC work plan.
