

**Alachua County Board of County Commissioners
Amendment 101**

This amendment (the “Amendment”) is made and entered into by and between Lutheran Services Florida, Inc. d/b/a LSF Health Systems, LLC (“LSF”) and Alachua County Board of County Commissioners (“Provider”) to be effective October 1, 2020. Provider and LSF may be referred to herein individually as a “party” or collectively as “the parties.”

Whereas, LSF wishes to amend the contract entered into between said parties on July 1, 2020, the purpose of this amendment is to modify contract language and update the Individuals Served table.

NOW THEREFORE, in consideration of the mutual covenants, and the mutual promises contained hereinafter, and in exchange for good and valuable consideration, the sufficiency of which is hereby acknowledged by the parties, as independent contractors, the parties agree as follows:

1. Capitalized terms herein shall be ascribed the meaning given by the Contract. In the event of conflict between this Amendment and the Contract, this Amendment shall control.
2. Standard Contract, Paragraph 3, ‘Payment for Services’ is amended to add Subparagraph 3.a.: “In the event that the Network Service Provider has funds remaining after paying the annual contract amount outlined in the current year’s Exhibit H – Funding Detail, and the Network Service Provider has delivered additional units of service in accordance with the terms and conditions of this contract for which the Network Service Provider has not been paid, the Managing Entity may, in its sole discretion, pay the Network Service Provider for some or all of the additional units of service entered into the Managing Entity’s data system by the Network Service Provider.” and is otherwise unchanged.
3. Standard Contract, Paragraph 36.j., ‘Employment Screening’ is amended to delete the following: “that are required by Florida law to be screened in accordance with § 435, Fla. Stat.” and is otherwise unchanged.
4. Attachment I, Section A, Paragraph 3.a.(2), ‘Individuals to be Served’ is amended to the following and is otherwise unchanged:
