## Alachua County Board of County Comissioners Amendment 100

This amendment (the "Amendment") is made and entered into by and between Lutheran Services Florida, Inc. d/b/a LSF Health Systems, LLC ("LSF") and Alachua County Board of County Comissioners ("Provider") to be effective July 15, 2020. Provider and LSF may be referred to herein individually as a "party" or collectively as "the parties."

Whereas, LSF wishes to amend the contract entered into between said parties on July 1, 2020, the purpose of this amendment is to decrease funding and modify contract language.

**NOW THEREFORE**, in consideration of the mutual covenants, and the mutual promises contained hereinafter, and in exchange for good and valuable consideration, the sufficiency of which is hereby acknowledged by the parties, as independent contractors, the parties agree as follows:

- 1. Capitalized terms herein shall be ascribed the meaning given by the Contract. In the event of conflict between this Amendment and the Contract, this Amendment shall control.
- 2. Standard Contract, Paragraph 3, 'Payment for Services' is amended to: "contract of an amount not to exceed **\$1,324,217.00**, or the rate schedule, subject to the availability of funds" and is otherwise unchanged.
- 3. Attachment I, Section B, Paragraph 1.a.(3)(h)3., 'Participation in Network Service Provider Monitoring' is amended to delete the following: "TANF." and is otherwise unchanged.
- 4. Attachment I, Section C, Paragraph 1, 'Payment Clause' is amended to: "contract total dollar amount shall not exceed **\$1,324,217.00**, subject to the availability of funds from the Department" and is otherwise unchanged.
- 5. Attachment I, Section C, Paragraph 7, 'Payments from Medicaid Health Maintenance Organizations, Prepaid Mental Health Plans, or Provider Services Networks' is amended to delete the following: "This includes services such as SIPP and the Florida Assertive Community Team (FACT)." and is otherwise unchanged.
- 6. Exhibit H, 'Funding Detail' is replaced in its entirety with the Exhibit H, 'Funding Detail' revised July 15, 2020 incorporated herein. All prior references to same content are deleted. The terms outlined in this Exhibit shall be retroactive to July 1, 2020.

Except as amended herein, the terms and conditions of the Agreement remain the same in full effect and authority.

The parties' authorized representatives have executed this three-page Amendment to be effective this 15<sup>th</sup> day of July, 2020.
