QUESTIONS & ANSWERS

- Q #1: The column named Estimated Annual Qty we see a number but are not sure if it is Boxes, Cases Etc. Please advise. Example: Line item 178 N-95 Masks.
- A #1: N-95 mask is an each quantity, specific items like the Microflex gloves will be by each box of gloves (100 per individual box).
- Q #2: Regarding that same line item the item number is N-95 Mask. Given the current crisis would KN-95 be an acceptable alternative.
- A #2: KN-95 is not acceptable
- Q #3: Would you be so kind as to clarify Columns shown below.

A #3: Use of these columns is intended to have the correct information relayed to us so that we can make the best informed decision.

When it comes down to awarding the winner of the bid, we ultimately need to know what "each" price is for the individual product.

We also want to know how many of a particular item is sold per box/case if they are sold that way so that we can order appropriately.

Some companies offer smaller packaging of the correct item and send a lower quote compared to a company with a larger box/case count who has a higher quote but may have a lower each price.
