A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, TO RECEIVE UNANTICIPATED REVENUE IN FUND 202, COMMUNITY DEVELOPMENT BLOCK GRANT CORONAVIRUS RELIEF FUNDING.

WHEREAS, the Board of County Commissioners of Alachua County, Florida ("Board") applied for and received a funding award for or from the federally-funded Community Development Block Grant – Coronavirus Relief Funding (CDBG-CV) Program; and

WHEREAS, State of Florida, Department of Economic Opportunity is the grantee agency for the State of Florida, designated to receive funds for the program purposes; and

WHEREAS, the Board is ready to implement such a project for the CDBG-CV program which will further benefit the public health, safety and welfare of Alachua County and its residents.

WHEREAS, it is necessary to recognize unanticipated revenue for fund 202 "CDBG-CV" to account for and administer revenues;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLOR IDA:

- 1. That the fiscal year 2023 budget for the CDBG-CV fund 202 amended as reflected in the budget amendment attached hereto as Exhibit "A".
- 2. By adoption of this resolution and the attached budget amendment, the Board of County Commissioners of Alachua County, Florida, hereby appropriates and permits the expenditure of the funds described therein, in accordance with the CDBG-CV grant agreement.
- 3. By adoption of this resolution the requested interfund loans are authorized from General Fund \$2,000,000 for Grant Fund 202 and \$800,000 for fund 206 to be repaid at the end of the grant, when reimbursement is received.
