LETTER OF INTEREST

The chance to create art for the Tax Collectors office- Alachua County presents an opportunity to innovate and push the envelope as the prospect is wide open. It would be both challenging and interesting to develop concepts that will excite the stakeholders who visit this office by introducing them to art. I am cognizant of creating a work of art using durable materials requiring minimal maintenance and I always consider sustainability.

The arc of my career has trained me to be a nimble and engaging artist. I methodically research, interview, and discover relevant details of a community and combine these qualities into iconic art. I am a people person and enjoy working with all age groups, and all types of people. Creating a thoughtful mural using license plates provided by the tax collector's office for one of the interior walls is in line with many of the public art projects I have completed. The preliminary artwork of the Fish motif using both license plates, glass tile and stained glass are materials that are durable for both the interior space or an exterior space.

I have helped obtain public art ordinances, written master plans, chaired public art committees and consulted for several cities, as well as created over 30 public art projects throughout Florida and the Nation. As a public art consultant

for two cities I know how to work with government agencies, arts councils, neighborhood organizations, and other relevant organizations.

My portfolio is extremely versatile and I work in several mediums.... always striving to be site specific, relevant, contemporary and exciting. I have been an artist my entire life. I have created glass tile and sculpted ceramic murals, free standing metal sculpture, terrazzo floor designs, and was a semifinalist twice for a suspended ceiling sculpture. I have worked in glass, clay, metal, terrazzo, painting, and other mediums for numerous projects and never design the same idea or technique. It is important to me to give the Tax collector's office an original work of art!

At all times I respond to the distinctive elements of a space, its surrounding environment and its end use. It is important that the conceptual and schematic designs appeal to a broad range of people of all ages and diversities, is timeless, has relevance to the community, and always establishes a "sense of place". I create ORIGINAL artwork from my hand, and the end result proves this to be true.

I have the technical expertise and practical knowledge for small to large-scale public art installations. I have the interpretive skills for creating unique site appropriate designs, and I am a consummate professional in all aspects of the art process. 

The golden sunset at the top of the design, and a salmon swimming upstream at the bottom is connected by an abstract forest of green leaf foliage and spiky pine needles all associated with the Pacific Northwest.

Each symbol corresponds to icons in both cultures yet express ideas unique to each, and to the community along with the importance of the cycle of life.

Mindscape was inspired by a group of laboratory scientists studying slices of the brain. The scientists infused the slides with colors and photographed them, resulting in images appearing like brilliant, incandescent, abstract paintings. The wall mural is a triptych, of stained, fused and slumped glass used to interpret the slide of the hippocampus, responsible for memory. Memory is vital to the ability to read, and therefore appropriate for the new Morgridge International Reading Center, a new facility at UCF to train teachers how to teach for the 21st Century.





I WILL WORK WITH AN INSTALLER I HIRE FROM ALACHUA COUNTY. THE DESIGN WILL BE ADHERED TO HARDY BACKER BOARD THAT HAS BEEN PRE-CUT INTO MANAGEABLE SIZE PIECES. THE ENTIRE DESIGN WHICH WILL NOW BE COMPOSED OF SEVERAL PIECES THAT I WILL TRANSPORT. THE ARTWORK PIECES WILL BE MECHANICALLY FASTENED WITH THE PROPER SCREWS TO THE WALL. IF THE COUNTY DESIRES, A STRONG ADHESIVE CAN BE PLACED ON THE BACK OF THE HARDIE BOARD AS WELL.

THERE IS VERY LITTLE MAINTENANCE WITH THE MATERIALS I AM PROPOSING. A DUSTING WITH A FEATHER DUSTER WHENEVER THE ARTWORK LOOKS DUSTY. IF ANY PERSON GETS DIRT ON THE ARTWORK, A SPONGE WITH A MILD SPRAY CLEANER AND PAPER TOWEL WILL SUFFICE.

- Ownership and maintenance: The County shall own the art acquired by the County under this chapter and all rights bargained for. The County Manager shall provide security and maintenance for the art. When appropriate, the County Manager shall request the artist provide a technical description of materials used in the art and maintenance instructions
