# Parks & Conservation Land

<u>19-0085</u> Fee Schedule changes and certain contracts for Parks and Conservation Lands

*Fiscal Consideration:* This approval will establish fees for use of the newly acquired Canterbury Equestrian Center so that the County may rent it to entities that do not already have existing contract that were assumed by the County at closing. Pursuant to Section 16.j. of the *Agreement to Purchase Real Estate between Alachua County and Canterbury Showplace, Inc.*, at closing on August 7, 2019, the County assumed 5 existing horse show contracts from the Seller. At closing, the Seller remitted to the County the deposits it received under said contracts and the County will receive all future payments due under said contracts.

The County does not currently charge the Alachua County Youth Fair and Livestock Show, Inc. for use of county-owned facilities, so including the exemption in the fee schedule has no fiscal impact; however, it allows the language to be removed from the standard contract.

There is no fiscal impact from itemizing the Gatornationals fees since the fees aren't changing; they are simply being clarified and formally included.
