RESOLUTION 22-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, AUTHORIZING THE SUBMITTAL OF APPLICATION TO THE STATE OF FLORIDA DEPARTMENT OF HEALTH, BUREAU OF EMERGENCY MEDICAL SERVICES, FOR FUNDS FROM THE EMERGENCY MEDICAL TRUST FUND, TO IMPROVE AND EXPAND PRE-HOSPITAL EMERGENCY SERVICES WITHIN ALACHUA COUNTY, PROVIDING AN EFFECTIVE DATE.

WHEREAS, the State of Florida maintains an Emergency Medical Services Trust Fund into which a portion of the collected County motor vehicle infraction fines are deposited; and,

WHEREAS, Alachua County is entitled to apply for a portion of such funds, which funds can only be used to improve and expand prehospital emergency medical services within Alachua County; and,

WHEREAS, it is estimated that Alachua County's share of such funds is approximately \$36,375.00; and,

WHEREAS, the Alachua County Department of Fire/Rescue Services proposed that an application be submitted to obtain such funds to upgrade the pre-hospital emergency medical services' response capabilities and to acquire specialized equipment, which would improve and expand pre-hospital emergency medical services; and,

WHEREAS, the Board of County Commissioners of Alachua County,

Florida wishes to authorize submittal of an application to obtain
the funds referenced herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

- 1. The Chair of the Board of County Commissioners is hereby authorized to submit an application to the State of Florida Department of Health, Bureau of Emergency Medical Services to obtain funds available to Alachua County from the Emergency Medical Trust Fund, which funds are to be used for the purpose of improving and expanding prehospital care by the Department of Fire/Rescue.
- 2. That the Chair of the Board of County Commissioners is hereby authorized to execute the application and any other documents necessary to obtain such funds.
- 3. The Board of County Commissioners herby certifies that such funds will expand and improve pre-hospital emergency medical services in Alachua County, and such funds will not be used to supplant the existing emergency medical services budget allocations.
- 4. That this resolution shall take effect immediately upon its adoption.
