AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS
OF ALACHUA COUNTY, FLORIDA, AMENDING CHAPTER 39.5
OF THE ALACHUA COUNTY CODE OF ORDINANCES TO ADD
NEW SECTION ENTITLED "ALACHUA COUNTY AFFORDABLE
HOUSING TRUST FUND"; ESTABLISHING THE ALACHUA
COUNTY AFFORDABLE HOUSING TRUST FUND; PROVIDING
FOR ALLOCATION AND THE USE OF FUNDS; PROVIDING FOR
ADMINISTRATION AND IMPLEMENTATION; PROVIDING FOR
SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE;
AND PROVIDING AN EFFECTIVE DATE.
WHEREAS, the Board of County Commissioners desires to establish a local program
for preserving and developing affordable housing that is sufficiently flexible to meet varied
and evolving housing needs and priorities while providing housing that is safe, sound, and
financially viable; and
WHEREAS, the Alachua County 2019-20 Charter Review Commission (CRC) obtained
public input and a ballot item was approved for the creation of an Alachua County Affordable
Housing Trust Fund; and
WHEREAS, the Board desires to establish an Alachua County Affordable Housing Trus
Fund to be used to create and sustain affordable housing in Alachua County, Florida; and
WHEREAS, it is intended that the Affordable Housing Trust Fund would be administered
by the Board of County Commissioners and administrative services would be provided by the
Community Support Services, Housing Program of Alachua County; and
WHEREAS, it is intended that revenue sources for this local affordable housing
program would be identified during Alachua County's annual budgeting process; and
WHEREAS, the establishment of the Affordable Housing Trust Fund will support
affordable housing and will provide a benefit to public health, safety and welfare.

COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, AS FOLLOWS: SECTION 1. <u>Recitals.</u> The foregoing recitals are incorporated herein by reference. SECTION 2. <u>Creation.</u> Chapter 39.5, Section 39.5.10, Alachua County Code, to be entitled "Alachua County Affordable Housing Trust Fund" shall be created to read as follows: <u>Sec. 39.5.10 – Alachua County Affordable Housing Trust Fund.</u>

- 7 (a) Establishment; Purpose. The Alachua County Affordable Housing Trust Fund
 8 Program ("Program") is established and is to be maintained within the accounts of
 9 the Board of County Commissioners. The purpose of the Trust Fund is to provide
 10 a fund to be used to create and sustain affordable housing and address the needs for
 11 affordable housing within Alachua County, Florida.
- (b) Allocation and Use of Trust Funds. The Affordable Housing Trust Fund may be funded by general revenue, fees from new commercial and residential development and other revenue sources as directed by the Board of County Commissioners, including those referenced in Alachua County Charter Review Commission Resolution 2020-04. All monies placed into the Trust Fund, including any interest earnings on such monies and repayments of loans made from such monies, shall be held in trust by Alachua County for uses provided herein:
 - in the development and provision of affordable community housing within Alachua County;
 - (2) to help in the preservation and expansion of the supply of such housing: to ensure that adequate sites for affordable community housing exist and remain available within Alachua County;
 - (3) to assist in the continued elimination of substandard housing conditions in Alachua County;
 (1) in Alachua County;
 - (4) to provide direct financial and technical assistance to qualified housing projects or eligible individuals;
 - (5) to fund approved, eligible operating expenditures related to the provision of and development of affordable community housing; or
 - (6) for any other use that creates or sustains affordable housing in Alachua County, as determined by the Board of County Commissioners.
- (c) Administration. The Program will be administered by the Board of County
 Commissioners in a manner consistent with the purposes of the Trust Fund.
 Alachua County Community Support Services, Housing Program will be
 responsible for administration and implementation of the Program and it may adopt
 policies and procedures for operation of the Program.
- 37 SECTION 2. Severability. If any word, phrase, clause, paragraph, section or provision of
- 38 this ordinance or the application hereof to any person or circumstance is held invalid or

unconstitutional, such finding shall not affect the other provisions or applications of the ordinance
 which can be given effect without the invalid or unconstitutional provisions or application, and to
 this end the provisions of this ordinance are declared severable.

SECTION 3. Inclusion in the Code. It is the intent of the Board of County Commissioners of Alachua County, Florida, and it is hereby provided that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of Alachua County, Florida; that the section of this ordinance may be renumbered or re-lettered to accomplish such intent and that the word "ordinance" may be changed to "section", "article", or other appropriate designation.

9 SECTION 4. <u>Effective Date.</u> A certified copy of this ordinance shall be filed with the 10 Department of State by the Clerk of the Board within ten (10) days after enactment by the Board 11 and shall take effect upon filing with the Department of State.
