**FIRST AMENDMENT TO AGREEMENT #10042
BETWEEN ALACHUA COUNTY AND UNIVERSAL ENGINEERING SERVICES, INC.,
FOR PROFESSIONAL GEO-TECHNICAL AND TESTING SERVICES**

THIS FIRST AMENDMENT TO AGREEMENT, made and entered into this 13th day of February A.D. 2018, by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and **Universal Engineering Services, Inc.**, hereinafter referred to as "Professional" (collectively the County and Professional are referred to as "Parties") :

WITNESSETH:

WHEREAS, the parties hereto previously entered into an the *Agreement for Continuing Services between Alachua County and Universal Engineering Services, Inc., for Professional Geo-Technical and Testing Services* dated September 27, 2016 (the "Agreement"); and,

WHEREAS, the parties wish to amend the agreement.

NOW, THEREFORE, **NOW, THEREFORE**, in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the parties, the parties hereby agree to amend the Agreement as follows:

A. PARAGRAPH # 5 of the Agreement, **Authorization for Services**, sub-paragraph 5.1 is amended in its entirety to read:

The Public Works Director, County Engineer or their designee is authorized to initiate and sign Work Orders and amendments and modifications to Work Orders on behalf of the County in an amount not to exceed the limitations outlined in Paragraph 6

B. PARAGRAPH # 6 of the Agreement, **Compensation**, is amended in its entirety to read:

The County agrees to compensate the Professional for the Professional services called for under this Agreement on either a "Fixed Fee" basis, a "Time Basis Method", or a combination of both, in an amount not to exceed \$ 500,000.00 annually unless approved by the Alachua County Board of County Commissioners. If a Work Order is issued under a "Time Basis Method," then Professional shall be compensated in accordance with the rate schedule attached as Attachment "C." If a Work Order is issued for a "Fixed Fee Basis," then the applicable Work Order Fixed Fee amount shall include any and all reimbursable expenses.

C. Attachment C, referenced in Paragraph #6 of the Agreement, **Compensation**, is hereby deleted in its entirety and replaced with the revised "Attachment C", which is attached to this First Amendment.

D. PARAGRAPH #7 of the Agreement, **Alachua County Minimum Wage**, is amended in its entirety to read:

7. Alachua County Minimum Wage:

- 7.1 Services rendered through this Agreement are considered covered services under Chapter 22, Article III, of the Alachua County Code of Ordinances ("Wage Ordinance"), which establishes a government minimum wage for certain contractors and subcontractors providing selected services to Alachua County government. "Covered Employees," as defined in Sec. 22.45 of the Wage Ordinance, are those employees directly involved in providing covered services pursuant to this Agreement
- 7.2 Current required Alachua County Government Minimum Wage is \$13.00 per hour when health benefits are offered at the equivalent value of \$2.04 per hour and \$15.04 when health benefits are not offered (collectively, the "Minimum Wage").
- 7.3 The County may amend the applicable Minimum Wage on or before October 1st of each year.
- 7.4 The Contractor must provide certification, **Attachment E** (attached to this Amendment), to the County that it pays each of its employees, who render services under this agreement, the Alachua County Government Minimum Wage, as may be amended by the County on or before October 1st of each year, as well as ensuring that it will require the same of its subcontractors throughout the duration of the Agreement
- 7.5 The Contractor shall prominently display a copy of the Wage Ordinance where it is easily seen by covered employees and supply to covered employees upon request. Additionally, the Contractor is responsible to make any person submitting a bid for a subcontract for covered services under this agreement aware of the requirements
- 7.6 Failure to comply with the provisions of the Wage Ordinance will be deemed a breach of contract and authorize the County to withhold payment of funds in accordance with Chapter 218, F.S
- 7.7 The Contractor will include the necessary provisions in subcontracts to ensure compliance. However, the County shall not be deemed a necessary, or indispensable, party in any litigation between the contractor and subcontractor

E. PARAGRAPH # 14 of the Agreement, **Project Records**, sub-paragraph 14.1, **General Provisions**, is amended with the addition of 14.1.3:

14.1.3 Professional shall ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of this

Agreement and following completion of this Agreement if the Professional does not transfer the records to the County.

F. PARAGRAPH # 14 of the Agreement, **Project Records**, is amended with the addition of the following provision:

IF THE PROFESSIONAL OR CONTRACTOR HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO THE CONTRACTOR'S DUTY TO PROVIDE PUBLIC RECORDS RELATING TO THIS CONTRACT, CONTACT ALACHUA COUNTY PUBLIC WORKS TRANSPORTATION AND ENGINEERING AT 352-374-5245, bsingleton@AlachuaCounty.us, 5620 N.W. 120th LANE, GAINESVILLE, FL 32653

G. This First Amendment shall take effect upon the date of execution by the parties

SAVE and EXCEPT as expressly amended herein, all other terms and provisions of the original agreement between the parties, dated **September 27, 2016**, shall be and remain in full force and effect.

Prior Board Motions

July 12, 2016 - Board approved finance report for RFP 17-149 authorizing staff to negotiate agreements with GSE and Universal.

September 27, 2016 - Board approved agreements with GSE and Universal

Fiscal Consideration:

Contracts will be used on an as-needed basis and engineering services are included in Department annual operating budgets and capital project budgets. Contract amendments have annual not to exceed amount of \$500,000.

Background:

Amendment are required to the agreement for compliance with the Wage Ordinance and to bring in-line with current operating procedures. These agreements provide routine geotechnical investigation and testing services associated with roadway, site & stormwater design, roadway, site & stormwater construction inspections, maintenance activities and QA/QC on geotechnical issues that arise during development, design or construction projects. The Public Works staff does not have the equipment, staff or the expertise to provide these services.
