

RESOLUTION 22-

A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF ALACHUA COUNTY,  
FLORIDA, AMENDING THE FY2021-2022  
ADOPTED BUDGET, ACCEPTING THE  
UNANTICIPATED REVENUE FROM THE GRIT  
FOUNDATION AND APPROPRIATING THE  
FUNDS TO REIMBURSE THE PURCHASES;  
PROVIDING AN EFFECTIVE DATE.

WHEREAS, the GRIT Foundation's mission is to generate community-based support for local first responders and hometown heroes; and,

WHEREAS, Alachua County Fire Rescue had an equipment need to better respond and care for patients during large scale events at the University of Florida; and,

WHEREAS, the GRIT Foundation has provided an award of \$56,606.21 for the purchase of two (2) chest compression devices and two (2) stair chair stretchers;

WHEREAS, it is necessary to amend the FY2021-2022 Budget to recognize the unanticipated revenue and appropriate the funds for expenditure; and,

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

1. That the fiscal year 2021-2022 Adopted budget is hereby adjusted as reflected in the budget amendment attached hereto.
2. By adoption of this resolution and the attached budget amendment, the Board of County Commissioners of Alachua County, Florida, hereby accepts the

revenue and appropriates the funds for the purchases.

3. That this resolution shall take effect immediately upon its adoption.
