

**SECOND AMENDMENT TO AGREEMENT FOR CONTRACTUAL SERVICES WITH
COLEMAN CONSTRUCTION, INC. #11797**

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and COLEMAN CONSTRUCTION INC, a Florida Corporation which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS the County and Contractor previously entered into a Contractual Services Agreement dated September 22, 2020 for Annual Roadway Construction Material Hauling Services, for Bid 20-65, identified by No. 11797 (the "Agreement"); and

WHEREAS the Parties previously entered into the First Amendment to the Agreement dated August 10, 2021, (the "First Amendment") through which the term of the Agreement was extended through September 30, 2022, to update the required Alachua County Minimum Wage, and to add a provision regarding the employment eligibility requirements of the U.S. Department of Homeland Security E-Verify System; and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to continue to furnish the goods or service to Alachua County; and

WHEREAS the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

A. Amendment. Section #1.1 of the Agreement titled "Term" is amended to read as follows:

1.1 This Agreement is effective beginning September 22, 2020 and is renewed until September 30, 2023, unless earlier terminated as provided herein.

B. Amendment. Exhibit 2 of the Agreement titled "Fee Schedule", is hereby deleted in its entirety and replaced with an updated Exhibit 2 Fee Schedule attached to this Amendment.

C. Effective Date. Upon and after full execution of this Amendment by the Parties, this Amendment shall be effective on October 1, 2022.

D. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.


