#11406 SECOND AMENDMENT TO ANNUAL ENVIRONMENTAL CONSULTING SERVICES WITH DB ENVIRONMENTAL INC.

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and DB ENVIRONMENTAL LABORATORIES INC, a corporation which is authorized to do business in the State of Florida ("Professional"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the County and Professional previously entered into a Professional Services Agreement, dated October 8, 2019, for Annual Environmental Consulting Services, identified by No. 11406 (the "Agreement"), and a First Amendment to the Agreement, dated September 8, 2020 (the "First Amendment"); and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Professional agree to amend the Agreement as follows:

A. <u>Amendment</u>. Section #1, of the Agreement titled "Term", sub-section 1.1 is amended to read as follows:

1.1 This Agreement is effective beginning October 8, 2019 and is renewed until September 30, 2024 (the "Second Renewal Option Term"), unless earlier terminated as provided herein.

B. <u>Amendment.</u> Exhibit #3, of the Agreement titled Standard Rates for Labor, Overhead, Markup, Fees, and Equipment is deleted in its entirety and replaced with the updated Exhibit #3 attached to this Amendment

C. <u>Effective Date</u>. Upon and after full execution of this Amendment by the Parties, this Amendment shall be effective on October 1, 2022.

D. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
