RESOLUTION OF THE BOARD OF COUNTY Α COMMISSIONERS OF ALACHUA COUNTY. FLORIDA. AMENDING RESOLUTION 18-52 TO ADJUST A NON-AD VALOREM ASSESSMENT FOR ROADWAY IMPROVEMENTS TO NE 210 AVENUE, NW 205 STREET, NW 218 AVENUE AND NW 202 STREET LOCATED IN THE UNINCORPORATED AREA OF ALACHUA COUNTY; DESCRIBING THE METHOD OF ASSESSING THE ROADWAY IMPROVEMENT COSTS AGAINST PROPERTY WITHIN THE SPECIAL ASSESSMENT DISTRICT; PROVIDING FOR EXCLUSION OF THE ASSESSMENT ON THE ASSESSMENT ROLL; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on June 9, 2015, The Board of County Commissioners of Alachua Couty adopted Resolution 15-58 imposing a Non-Ad Valorem Assessment for roadway improvements to NW 210 Avenue, NW 205 Street, NE 218 Avenue and NW202 Street in the unincorporated area of Alachua County.

WHEREAS, on July 10, 2018, The Board of County Commissioners of Alachua Couty adopted Resolution 18-52, amending Resolution 15-58.

WHEREAS, on September 25, 2018, The Board of County Commissioners of Alachua Couty adopted Resolution 18-85, amending Resolution 18-52.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

WHEREAS, the Board of County of County Commissioner of Alachua County, Florida (hereinafter , the "Board") , found that the roadway improvement to portions of NW 210 Avenue, NW 205 Street , NW 218 Avenue , and NW 202 Street within Alachua County , specifically identified and described in **Exhibit "A"** are necessary for the health , safety , and welfare of the citizens of Alachua County, Florida ; the Board of County Commissioners recognizes there are 3 years left on the assessment.

- That resolution 18-85 is hereby amended and beginning Fiscal Year 22-23 the Non-Ad Valorem Assessment for NW 210 Avenue, NW 205 Street, NE 218 Avenue and NW202 Street, specifically identified and described in Exhibit "A" in the unincorporated area of Alachua County be eliminated for the parcels specifically identified in Exhibit "D".
- By adoption of this resolution, the Board of County Commissioners of Alachua County, Florida hereby appropriates and permits the expenditure of County funds to repay the outstanding balance owed related to this assessment.

- By adoption all parcels with outstanding balances indicated on Exhibit "D" are to have their balances forgiven in the amount of \$24,816.82 and the Tax Collector notified to remove the assessment from the parcels.
- By adoption Fund 311 account balance of \$24,816.82 shall be written off utilizing General Fund Reserves.
- 5. By adoption a Transfer of \$124,095.44 from General Fund Reserves to Fund 311 to complete and close the outstanding interfund loan.
- 6. By adoption of this resolution, the Board of County Commissioners of Alachua County, Florida directs staff to work with the city of High Springs to assist the County in the repayment of the outstanding balance owed related to this assessment.
- 7. That this resolution shall take effect immediately upon its adoption.
