Founded the Alachua County African and African American Historical Society, Inc., as a 501c3 corporation in 2020 to bring together other organizations committed to preserving and disseminating Black History in Alachua County. As Chair of the Alachua County African American History Task Force, we worked with the Alachua County Public Schools to ensure that an African American History course is taught in each of the high schools, and promoted the Infusion Model to include this history and experience throughout the K-12 curriculum. As a result of the ACAAHTF work with ACPS, the school district achieved Exemplary Status by the Florida African American History Task Force. Received the Distinguished Alumni Award in 2019 for work as National Historian of the Bethune-Cookman National Alumni Association (now Mary McLeod Bethune National Alumni Association). President of the Gainesville Chapter of the United Nations Association of USA (UNA-USA), focusing on the 17 Sustainable Development Goals (SDGs) of the United Nations: Diversity, Equity Accessibility, Equity, and Inclusion; Climate Change. Chaired United Nations Day 2019, 2020, and 2021; and initiated UNA Essay Contest in 2020 to award cash prizes to middle school students who submitted essays on designated topics. Co-editor of the book, African American Studies: 50 Years at the University of Florida (2021). An active member of the UF African American Studies Program Advisory Committee to suggest policies, directions, and programs of research. Mentor in the UF Active Learning Program (ALP) a semester-long course that gives undergraduate students opportunities to conduct supervised research in the local community.
