4TH AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND JONES EDMUNDS & ASSOCIATES, INC. FOR ANNUAL ENGINEERING SERVICES NO. 10835

THIS FOURTH AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Jones Edmunds & Associates, Inc., a Florida for Profit Corporation, which is authorized to do business in the State of Florida ("Professional"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the Parties previously entered into an Agreement dated February 13, 2018 for Annual Engineering Services, identified by No. 10835 (the "Agreement"); and

WHEREAS, the Parties previously entered into the First Amendment to the Agreement dated September 10, 2019 (the "First Amendment"), the Second Amendment to the Agreement dated September 22, 2020 (the "Second Amendment"), and the Third Amendment to the Agreement dated October 12, 2021 (the "Third Amendment"); and

WHEREAS, the Parties desire to further amend the Agreement to change the rates paid to the Professional provided herein.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Attachment C, of the Agreement titled "Fee Schedule" is amended in its entirety and replaced with a new Attachment C, attached to this Amendment.
- B. <u>Amendment</u>. Paragraph 14 of the Agreement regarding Public Records is amended to modify out the last paragraph with the following. All other portions of paragraph 14 remain unchanged by this Amendment.

In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
