THIRD AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND WSP USA ENVIRONMENT & INFRASTRUCTURE, INC. (FORMERLY WOOD ENVIRONMENT & INFRASTRUCTURE SOLUTIONS, INC.) FOR ANNUAL ENVIRONMENTAL SERVICES NO. 11408

THIS THIRD AMENDMENT TO AGREEMENT "Amendment"), made and entered into by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and Wood Environment & Infrastructure Solutions, Inc. now known as WSP USA Environment & Infrastructure, Inc., hereinafter referred to as "Professional." Collectively, the County and the Professional shall be referred to herein as the "Parties."

WITNESSETH:

WHEREAS, the County and Wood Environment & Infrastructure Solutions, Inc. entered into a Professional Services Agreement dated October 8, 2019, for Annual Environmental Consulting Services (the "Agreement"), identified by No. 11408; and

WHEREAS, the County and Wood Environment & Infrastructure Solutions, Inc. entered into the First Amendment to the Agreement, dated September 8, 2020 which, among other things, extended the term of the Agreement through September 30, 2022 ("First Amendment"); and

WHEREAS, the County and Wood Environment & Infrastructure Solutions, Inc. entered into the Second Amendment to the Agreement, dated August 30, 2022, which, among other things, extended the term of the Agreement through September 30, 2024 ("Second Amendment"); and

WHEREAS, on September 23, 2022, the County was notified that Wood Environment & Infrastructure Solutions, Inc. was acquired by WSP Global, Inc. and resulted in a name change; and

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereby agree to amend the Agreement as follows:

- A. <u>Recitals</u>. The Parties agree that the Recitals set forth above are true and correct and are incorporated into, and made part of, this Third Amendment.
- B. <u>Amendment</u>. Effective upon September 21, 2022, the Agreement and its amendments and attachments are assigned from the entity named Wood Environment & Infrastructure Solutions, Inc. to WSP USA Environment & Infrastructure Inc. has agreed to assume all of Wood Environment & Infrastructure Solutions, Inc's rights, duties, obligations, and responsibilities under the Agreement. The County consents to the assignment and assumption, and WSP USA Environment & Infrastructure, Inc. agrees to be bound in all respects by the terms of the Agreement, as amended. Accordingly, the name of the Professional as shown in the Agreement is hereby amended to be "WSP USA Environment & Infrastructure Inc."

- C. <u>Amendment</u>. In accordance with Paragraph 13 of the Agreement, titled Insurance, and Exhibit 5 of the Agreement, titled Insurance Requirements, the Professional shall provide a current Certificate of Insurance, with the requisite coverages, in the new name of the Professional, WSP USA Environment & Infrastructure, Inc.
- D. Effective Date. This Amendment shall be effective on upon execution by both Parties
- E. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
