A RESOLUTION OF THE BOARD OF
COUNTY COMMISSIONERS OF ALACHUA
COUNTY, FLORIDA, INCREASING
THE FY18-19 REVENUE AND
EXPENDITURE BUDGET FOR THE "EMPG
FEDERAL GRANT 7/19-6/20" FUND;
RECOGNIZING REVENUES AND
EXPENDITURES; PROVIDING AN
EFFECTIVE DATE.

WHEREAS, it is necessary to establish the
budget for grant entitled "EMPG FEDERAL GRANT 7/19-
6/20" to account for the receipt and disbursement of funds
from the State of Florida, Division of Emergency Management
grant award; and

WHEREAS, the grant award provides for grant
funds to be used to help fund a regional, State grant
coordinator to assist counties in Northeast Florida,
which helps enhance preparation, response and recovery from
terrorist events that may occur within, or otherwise
affect, Alachua County; and,

WHEREAS, the total grant award is in the amount of
\$84,626.00.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF
COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

1. That the revenues and expenditures of the
"EMPG FEDERAL GRANT 7/19-6/20" FUND budget are hereby
amended as reflected in the budget amendment attached hereto

as Exhibit A.

2. By adoption of this resolution and the attached budget amendment, the Board of County Commissioners of Alachua County, Florida, hereby appropriates and permits the expenditure of the funds described therein.

3. That this resolution shall take effect immediately upon its adoption.
