

**FIRST AMENDMENT TO AGREEMENT  
FOR ANNUAL PAVEMENT MARKING SERVICES, #10956,  
BETWEEN ALACHUA COUNTY AND ROADScape NORTH FLORIDA, INC.**

THIS FIRST AMENDMENT TO AGREEMENT, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_ A.D. 20\_\_\_\_, by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and Roadscape North Florida, Inc., with a business address of 14476-704 Duval Place, Jacksonville, FL 32218 hereinafter referred to as "Professional". Collectively, the County and the Professional are hereinafter referred to as the "Parties".

**WITNESSETH:**

**WHEREAS**, in 2018, the County issued Bid #18-6 seeking Firm Fixed Bids from interested Contractors for the provision of Annual Pavement Marking Services; and

**WHEREAS**, after evaluating all timely responses to Bod #18-6 the County identified the Contractor as one of the top ranked firms; and

**WHEREAS**, pursuant to Bid #18-6, the Parties hereto previously entered into the *Agreement for Annual Pavement Marking Services between Alachua County and P&P Striping, LLC.*, dated July 10, 2018 (the "Agreement"); and

**WHEREAS**, the County has elected to exercise its first option to renew the Term of the Agreement for a one year period commencing October 1, 2019 through September 30, 2020 ("First Renewal Option Term"); and

**WHEREAS**, the Parties also wish to amend the Agreement to reflect the increase to the Alachua County Minimum Wage as mandated by the Alachua County Code of Ordinances, Chapter 22, Article III ("Wage Ordinance").

**NOW, THEREFORE**, in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereby agree to amend the Agreement as follows:

A. SECTION #1 of the Agreement, **Term**, is amended and replaced in its entirety to read:

The County has elected to exercise its first option to renew the Term of the Agreement. Accordingly, the Term of the Agreement is renewed for the period of October 1, 2019 through and ending September 30, 2020 (the "First Renewal Option Term"), unless earlier terminated as provided herein. The County has the

option of renewing this Agreement for one (1) additional one (1) year period at the same terms and conditions outlined herein.

The County's performance and obligation to pay under this Agreement is contingent upon a specific annual appropriation by the Alachua County Board of County Commissioners ("Board"). The Parties hereto understand that this Agreement is not a commitment of future appropriations. Therefore, the continuation of this Agreement beyond the end of any fiscal year shall be subject to both the appropriation and the availability of funds in accordance with Chapter 129, Florida Statutes, and that the failure of the Board to do so shall not constitute a breach or default of this Agreement.

B. Section #7 of the Agreement, Alachua County Minimum Wage, sub-section 7.2 is amended in its entirety to read:

Current required Alachua County Government Minimum Wage is \$14.00 per hour when health benefits are provided at the equivalent value of \$2.17 per hour and \$16.17 when health benefits are not provided (collectively, the "Minimum Wage").

C. This First Amendment shall take effect commencing October 1, 2019 after execution by all Parties.

D.SAVE and EXCEPT as expressly amended herein, all other terms and provisions of the Agreement shall be and remain in full force and effect.
