My political work and issue organizing around County issues such as ballot referendums and political campaigns has given me a unique ability to understand the legal and technical obstacles to creating good language that may emerge from experts and community activists, but that are digestible and meaningful to the public, which I see as a chief challenge to the CRC. I'm deeply familiar with a broad range of demographic interests from our County's mental health community and addiction recovery citizens to its commercial construction companies and the trade workers associated with them. I have consistently been devoted at an individual and organizational level with land use, safe and affordable housing, conservation issues, and am currently contributing to charter issue discussions at Gainesville's CRC (not a member of that body). Through my advocacy I am broadly familiar with the structure of County government, its staff, its hallmark issues, and with its Charter context. Finally, I've put my feet or my bicycle wheels on just about every inch of limerock road, highway, green space, and unpaved trail in this County, so I am deeply familiar with its physical contours and resources. I've lived in small townships, in Gainesville, and currently reside in the unincorporated County. I grew up in a rural South Texas county exactly our size, but I'm attuned to the relationship between town and country, especially regarding potential governance issues a CRC might address. I'm comfortable speaking up when a body or meeting is not operating according to protocol, explaining to body members what I believe each other is trying to communicate, and encouraging the public to be comfortable speaking in what may for some be an intimidating room filled with experts, appointed members, and knowledgeable staff. I would go out of my way to ensure that the general public is made as much aware of the work of the CRC as possible, and that all feel welcome to come forth with ideas for ballot items that would improve our County.
