### Call to Order

The meeting was called to order at 4:46 p.m.

### Approval of the Agenda

Carla Lewis-Miles made a motion to approve the agenda as presented; Amy Kauper seconded; unanimous approval.

### **Approval of Minutes**

**MOTION:** Amy Kauper made a motion to approve the July 15 minutes as presented; Carla Lewis-Miles seconded; unanimous approval.

#### **Election of Vice Chair**

**MOTION:** Amy Kauper made a motion to elect Joni Ellis as Vice Chair; Carla Lewis-Miles seconded; unanimous approval.

### Discussion of Oct. 1, 2017 – Sept. 30, 2018 Financial Reports

City of High Springs – The City of High Springs has agreed to install a fence to ensure it is evident that it is open to the public. The Board requested clarification as to when the project would start (i.e. Oct. 1, 2019 or Oct. 1, 2020).

City of Gainesville – The City of Gainesville sent a letter to the WSPP Citizens Oversight Committee dated July 22. Chair Bukata stated that his only remaining concern is the transition of paying WSPP Department staff salaries from WSPP funds to the General Fund. **MOTION:** Joni Ellis made a motion to send a letter to the City of Gainesville; the motion died for a lack of a second. Ms. Boyce stated that the

minutes from the prior meeting included a motion to table the letter and reconsider it at the August meeting.

**MOTION**: Carla Lewis-Miles made a motion to discuss the letter; Joni Ellis seconded. **AMENDED MOTION**: Carla Lewis-Miles amended her motion to discuss and edit the letter; Joni Ellis seconded; unanimous approval.

The Oversight Board discussed and edited the DRAFT letter. **MOTION:** Joni Ellis made a motion to approve and send the letter; Amy Kauper seconded; Carla Lewis-Miles and David Ruiz opposed; motion died 2:2.

### Public Comment

Sally Morit – is passionate about saving Camp McConnell. She also stated that there is a property on 441 North and 33<sup>rd</sup> Street or Avenue currently slated for a car wash, but believes it would make an ideal pocket park. The Council recommended she contact the City's Department of Doing to determine the status of the project.
