**Dear Chairman Chestnut:** 

The Department of Economic Opportunity ("Department") has completed its review of the proposed comprehensive plan amendment for Alachua County (Amendment No. 19-01ER), which was received on July 5, 2019 and determined complete on July 8, 2019. We have reviewed the proposed amendment in accordance with the state coordinated review process set forth in Sections 163.3184(2) and (4), Florida Statutes (F.S.), for compliance with Chapter 163, Part II, F.S. The Department does not identify any objections or comments to the proposed amendment and this letter serves as the Objections, Recommendations and Comments Report. Review comments received by the Department from the appropriate reviewing agencies, if any, are enclosed.

The County should act by choosing to adopt, adopt with changes, or not adopt the proposed amendment. For your assistance, we have enclosed the procedures for final adoption and transmittal of the comprehensive plan amendment. **The second public hearing**, which shall be a hearing on whether to adopt one or more comprehensive plan amendments, **must be held within 180 days** of your receipt of the Department's attached report, or the amendment will be deemed withdrawn unless extended by agreement with notice to the Department and any affected party that provided comment on the amendment pursuant to Section 163.3184(4)(e)1., F.S.

Pursuant to Section 163.3184(4), Florida Statutes, (F.S.) in its role as a reviewing agency as identified in Section 163.3184(1)(c), F.S., the Florida Department of Transportation (FDOT) reviewed proposed amendment, Alachua County 19-1ER.

Alachua County proposes amendments to every Element and the Future Land Use Maps (FLUM) Series of the County's Comprehensive Plan based upon evaluation according to section 163.3191 of the Florida Statutes. Changes in the Comprehensive Plan were necessary due to changes in state statutory requirements.

Among the changes in the Comprehensive Plan include the repeal of transportation concurrency and clarification of existing policies relating to the County's alternative mobility funding system, deletion of concurrency exceptions in Policies 1.19 through 1.1.10.1 of the Transportation Mobility Element, removal of the Transportation Backlog Authority (TBA) as statutory revisions have changed TBA's to Transportation Development Authorities.

FDOT has determined the proposed amendment has no significant adverse impacts on important State transportation resources or facilities within its jurisdiction.

Pursuant to Section 163.3184, Florida Statutes, Council review of local government comprehensive plan amendments is limited to adverse effects on regional resources and facilities identified in the strategic regional policy plan and extrajurisdictional impacts that would be inconsistent with the comprehensive plan of any affected local government within the region. #### DESCRIPTION OF AMENDMENT

The County is amending its comprehensive plan based on an evaluation completed by the County to reflect changes in state requirements pursuant to Section 163.3191, Florida Statues. More specifically, the item amends the Future Land Use Map as well as the text of the Future Land Use Element; the Transportation Mobility Element; the Conservation Element; the Conservation and Open Space Element; the Recreation Element; the Historic Element; the Capital Improvements Element; the Potable Water and Sanitary Sewer; the Stormwater Element; the Solid Waste Element; the Housing Element; the Economic Element; the Intergovernmental Coordination Element; the Public School Facilities Element; the Energy Element; and the Community Health Element (see attached excerpts).
