4 A RESOLUTION OF THE BOARD OF COUNTY  
5 COMMISSIONERS OF ALACHUA COUNTY, FLORIDA,  
6 AUTHORIZING THE ALACHUA BOARD OF COUNTY  
7 COMMISSIONERS TO PARTICIPATE IN JOINT  
8 MEETINGS HELD OUTSIDE OF ALACHUA COUNTY WITH  
9 THE (enter name of county) COUNTY COMMISSION TO  
10 DISCUSS MATTERS OF MUTUAL INTEREST; PROVIDING  
11 REQUIREMENTS FOR SUCH MEETINGS; AND PROVIDING  
12 AN EFFECTIVE DATE.

13 WHEREAS, the Alachua County Board of County Commissioners (the Board) may have  
14 a desire to meet with the (enter name of county) County Board of County Commissioners to  
15 discuss matters of mutual interest; and

16 WHEREAS, Section 125.001, Florida Statutes (2019), permits the Board to hold  
17 meetings outside of Alachua County for the purpose of jointly meeting with the governing bodies  
18 of one or more adjacent counties or municipalities; and

19 WHEREAS, Section 125.001, Florida Statutes, further states that such meetings may  
20 be held at any appropriate public place within the jurisdiction of any participating county or  
21 municipality, and requires that due public notice be provided within the jurisdiction of  
22 all participating municipalities and counties; and

23 WHEREAS, Section 125.001, Florida Statutes, further requires that the governing  
24 body of a county or municipality must first adopt a resolution authorizing participation in  
25 joint meetings.

1           **NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY**  
2           **COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:**

3           **Section 1.** The Alachua County Board of County Commissioners is hereby authorized to  
4 hold joint meetings with the (enter name of county) County Board of County Commissioners;  
5 these meetings may be held in one of the counties of the governing bodies on a date and at a time  
6 to be determined.

7           **Section 2.** No joint meeting authorized herein shall take the place of any public hearing  
8 required by law, and the Board shall take no official action or vote.

9           **Section 3.** The Board shall provide due public notice of the date, time, and location for  
10 any such meeting both within the jurisdiction of Alachua County and the jurisdiction of (enter  
11 name of county) County.

12           **Section 4.** This resolution shall take effect immediately upon its adoption and is valid  
13 through the 2020 calendar year.
