NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

Section 2. No joint meeting authorized herein shall take the place of any public hearing required by law, and the Board shall take no official action or vote.

Section 3. The Board shall provide due public notice of the date, time, and location for any such meeting both within the jurisdiction of Alachua County and the jurisdiction of (entername of county) County.

Section 4. This resolution shall take effect immediately upon its adoption and is valid through the 2020 calendar year.
