AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN ALACHUA COUNTY AND THE TOWN OF LACROSSE FOR BUILDING PERMIT AND INSPECTION

THIS FIRST AMENDMENT TO INTERLOCAL AGREEMENT ("First Amendment"), made
and entered into this day of 20, by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County
Commissioners, hereinafter referred to as "County", and the Town of LaCrosse, a municipal corporation of the
State of Florida, hereinafter referred to as "Town." Collectively, the County and Town are hereinafter referred
to as the "Parties."
WITNESSETH:
WHEREAS, the Parties hereto previously entered into the Interlocal Agreement between Alachua
County and the Town of Lacrosse for Building Permit and Inspection Services dated September 24, 2002; and
WHEREAS, the Town has asked the County to provide additional inspection services, specifically sit
inspections of horizontal development conducted through the Town's development process; and
WHEREAS, the County has the expertise in their Public Works Department to conduct the inspection
and desires to conduct the Inspections for the Town; and
WHEREAS, the Parties wish to amend the agreement as set forth herein.
NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein,
and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the
Parties, the Parties hereby agree amend the Agreement as follows:
A. SECTION #2 of the Agreement, Applicable Code Requirements, is hereby amended by addition of

For the conduct of site and subdivision inspections of horizontal development, the County shall

utilize the site/subdivision plans approved by the Town and Town of Lacrosse Land Development Regulations.

- B. **SECTION** # 3 of the Agreement, **Duties**, is amended in its entirety to read: Section 3. <u>Duties</u>.
 - 1. The Town shall designate the County as the agency of government to issue building permits, conduct site and subdivision inspections of horizontal development, and collect the fees to cover the cost of plan review, inspections, and administration of said permits.
 - 2. The County agrees to provide personnel necessary to perform building inspections, site and subdivision inspections of horizontal development, plan review, issue permits, and provide adequate administration, implementation, and enforcement of the Code described in Section 2 of this Agreement.
- C. SECTION #4 of the Agreement, Personnel, is hereby amended by the addition of the following:

For the conduct of the site and subdivision inspections of horizontal development the County may utilize contracted personnel procured in accordance with the County procurement code.

D. This First Amendment shall take effect and become effective after execution by both Parties and a copy of this First Amendment is filed with the clerk of the circuit court in and for Alachua County, Flordia.

SAVE and EXCEPT as expressly amended herein, all other terms and provisions of the Agreement between the Parties shall be and remain in full force and effect.
