

RESOLUTION - 20

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, INCREASING THE FUND BALANCE FOR THE SOLID WASTE FUND FOR UNANTICIPATED REVENUES FROM THE RECYCLING INTERLOCAL WITH HERNANDO COUNTY BOARD OF COUNTY COMMISSIONERS PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is necessary to increase the fund balance of the Solid Waste Fund to account for and administer revenue funds from processing and selling recycling commodities;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

1. That the increase in the Solid Waste Fund, and the same is hereby, approved.
2. That the fiscal year 2019-20 budget for the Solid Waste Fund is hereby amended as reflected in the budget amendment attached. By adoption of this resolution and the attached budget amendment, the Board of County Commissioners of Alachua County, Florida, hereby appropriates and permits the expenditure of the funds described therein.
3. That this resolution shall take effect immediately

upon its adoption.
