

RESOLUTION 20-

A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, TO
RECEIVE UNANTICIPATED REVENUE IN FUND 018, VICTIMS OF
CRIME ACT (VOCA) GRANT FROM THE OFFICE OF THE
ATTORNEY GENERAL (OAG); PROVIDING AN EFFECTIVE
DATE.

WHEREAS, on September 24, 2019 the Alachua County Board of County
Commissioners approved the Victims of Crime Act (VOCA) grant award and contract;

WHEREAS, the grant award was in the amount of \$458,976 and the Fiscal Year
2020 Adopted Budget is \$315,863;

WHEREAS, an adjustment to the Fiscal Year 2020 Adopted Budget is needed
to receive the unanticipated revenue.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF THE ALACHUA COUNTY, FLORIDA;

- I. The receipt of the unanticipated revenue from the Victims of Crime Act (VOCA) grant is hereby approved.
2. The Fiscal Year 2020 Adopted Budget for the Victims of Crime Act (VOCA)
amended and appropriated as reflected in the budget amendment, attached
hereto as "Attachment A."
3. By adoption of this resolution and the attached budget amendment, the Board of
County Commissioners of Alachua County, Florida, hereby appropriates and
permits the receipt and expenditure of the funds described herein.

4. That this Resolution shall take effect immediately upon its adoption.
