WHEREAS, it Is necessary to establish the budget for grant entitled "EMPG-S COVID-19 Supplemental Federal Grant" to account for the receipt and disbursement of funds from the State of Florida, Division of Emergency Management grant award; and

WHEREAS, the grant award provides for grant funds to be used to help fund a regional, State grant coordinator to assist tribes and local governments with their public health and emergency management activities supporting the prevention of, preparation for, and response to the ongoing Coronavirus Disease 2019 (COVID-19) public health emergency; and,

WHEREAS, the total grant award is in the amount of \$17,862.82.
