WHEREAS, the parties hereto previously entered into an agreement September 13, 2016;

to lease office space at 14 South Main Street, Gainesville, Florida; and,

WHEREAS, the parties wish to amend the agreement.

NOW, THEREFORE, the parties hereby agree to amend the Lease Agreement dated September 13, as follows:

A. SECTION #2. <u>Term</u>, is amended in its entirety to read as follows:

The Term of the lease shall begin October 1, 2017 and shall end September 30, 2018, unless earlier terminated as provided herein.

B. SECTION #4. <u>Rent</u>, is amended in part to read as follows:

A. From October 1, 2017 through September 30, 2018, the Tenant agrees to pay the Landlord monthly rental payments of Four Thousand Seven Hundred and One Dollars and Thirty One Cents (\$4,701.31).

C. This First Amendment shall take effect upon the expiration of the original agreement.
