#### WITNESSETH:

**WHEREAS**, in 2019, the County issued Bid#19-214 seeking Contractors to provide Firm Fixed Prices for Annual Right-Of-Way Mowing in Alachua County, Florida; and

**WHEREAS**, after evaluating and considering all timely responses to Bid #19-214 the County identified the Contractor as the top ranked firm; and

**WHEREAS**, pursuant to Bid #19-214 the Parties hereto previously entered into the Agreement for Contractual Services between Alachua County and Green Maintenance And Cleaning Inc. dated March 12, 2019 (the "Agreement") for the provision of Annual Right-Of-Way Mowing; and

WHEREAS, the Parties entered into the First Amendment to the Agreement (the "First Amendment"), dated September 24, 2019, through which the County elected to exercise its first option to renew the Term of the Agreement for a one year period commencing October 1, 2019 and continuing through September 30, 2020 ("First Renewal Option Term"), add additional service areas to the Scope of Work, and to adjust the Annual Contract Price to account for the additional scope; and

WHEREAS, the County has elected to exercise its second option to renew the Term of the Agreement for a one year period continuing through September 30, 2021 ("Second Renewal Option Term"), add additional service areas and cycles to the Scope of Work, to reflect the increase to the Alachua County Minimum Wage as mandated by the Alachua County Code of Ordinances, Chapter 22, Article III ("Wage Ordinance") and to adjust the Annual Contract Price to account for the additional scope; and

**WHEREAS**, the Parties wish to amend the Agreement as set forth herein.

**NOW, THEREFORE**, in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereby agree to amend the Agreement as follows:

#### A. SECTION # 1 of the Agreement, **Term**, is amended in its entirety to read:

- 1.1 The County has elected to exercise its second option to renew the Term of the Agreement. Accordingly, the Term of the Agreement is renewed for the period commencing upon of this Second Amendment by the Parties and continuing through and ending September 30, 2021 (the "Second Renewal Option Term), unless earlier terminated as provided herein. The County has the option of renewing this Agreement for one (1) additional one (1) year period at the same terms and conditions outlined herein.
- 1.2 The County's performance and obligation to pay under this Agreement is contingent upon a specific annual appropriation by the Alachua County Board of County Commissioners ("Board"). The Parties hereto understand that this Agreement is not a commitment of future appropriations. Therefore, the continuation of this Agreement beyond the end of any fiscal year shall be subject to both the appropriation and the availability of funds in accordance with Chapter 129, Florida Statutes, and that the failure of the Board to do so shall not constitute a breach or default of this Agreement.
- B. Sub-paragraph 4.2 of the Agreement, is hereby amended and replaced in its entirety to read:
  - 4.2 The Contractor shall be paid a sum that SHALL NOT EXCEED Two Hundred Sixty-Five Thousand Dollars and Zero Cents (\$265,000.00) per Fiscal Year ("Annual Contract Price"), unless

approved by the Board of County Commissioners. For the purposes of this Agreement, a Fiscal Year shall commence on October 1 and shall extend through September 30.

- C. Subparagraph 5.1 of the Agreement, is hereby amended and replaced in its entirety to read:
  - 5.1 The current required Alachua County Government Minimum Wage is \$14.00 per hour when health benefits are provided at the equivalent value of \$2.17 per hour and \$16.17 when health benefits are not provided (collectively, the "Minimum Wage").
- D. Paragraph 2, entitled **List of Roadways**, of Exhibit 1, entitled **Scope of Work**, as amended by the First Amendment, is further amended and replaced in its entirety with the following:

The County shall determine the means and methods by which electronic signatures may be used to execute this Agreement and shall provide the Contractor with instructions on how to use said method. Delivery of this Agreement or any other document contemplated hereby bearing an manually written or electronic signature by facsimile transmission (whether directly from one facsimile device to another by means of a dial-up connection or whether mediated by the worldwide web), by electronic mail in "portable document format" (".pdf") form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, will have the same effect as physical delivery of the paper document bearing an original or electronic signature.

- F. Exhibit 2, entitled **Mowing Costs**, is hereby amended and replaced in its entirety with the updated Exhibit 2 attached to this Second Amendment.
- G. This Second Amendment shall take effect upon the date of execution by both Parties.
- H. **SAVE and EXCEPT** as expressly amended herein, all other terms and provisions of the Agreement shall be and remain in full force and effect.
