

**SECOND AMENDMENT TO THE AGREEMENT  
BETWEEN ALACHUA COUNTY AND  
GAINESVILLE SPORTS ORGANIZING COMMITTEE, INC dba GAINESVILLE SPORTS  
COMMISSION FOR A SPORTING EVENTS BID POOL**

THIS SECOND AMENDMENT TO AGREEMENT, made and entered into this 28<sup>th</sup> day of October A.D., 2008, by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and Gainesville Sports Organizing Committee, Inc dba Gainesville Sports Commission, hereinafter referred to as Agency:

WITNESSETH:

WHEREAS, the Agency provides services to promote sporting events in Alachua County by utilizing Tourist Development Tax to set up a bid process and bid pool; and

WHEREAS, the County finds that the activity is in the best interest of its citizens by providing marketing or advertising designed to increase tourist-related business activities within the County; and

WHEREAS, §125.0104, Florida Statutes provides that funding may be provided from the tourist development tax for this purpose; and

WHEREAS, the parties entered into an Amended and Restated Agreement on October 10, 2006 for the provision of services by the Agency related to the promotion of sports events in Alachua County by utilizing the Tourist Development Tax to set up a bid process and bid pool; and,

WHEREAS, the parties previously entered into the First Amendment to the Agreement on January 8, 2008;

NOW THEREFORE, the parties hereto agree to further amend agreement dated October 10, 2006 as follows:

A. Section 1, Term of the Agreement is amended in its entirety to read:

1. Term - This agreement shall commence on October 1, 2008 and continue through September 30, 2013 unless earlier terminated as provided herein. The parties may extend the term of this agreement through an amendment approved by both parties.


B. This amendment shall take effect upon expiration of the agreement currently in effect at

the terms and specifications contained therein.


