SECOND AMENDMENT TO THE RESTATED AND AMENDED AGREEMENT BETWEEN ALACHUA COUNTY AND GAINESVILLE SPORTS ORGANIZING COMMITTEE, INC dba GAINESVILLE SPORTS COMMISSION FOR ADMINISTRATION

THIS SECOND AMENDMENT TO THE AGREEMENT, made and entered into this 24th day of 5et and a A.D., 2063, by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and GAINESVILLE SPORTS ORGANIZING COMMITTEE, INC dba GAINESVILLE SPORTS COMMISSION, hereinafter referred to as AGENCY:

WITNESSETH:

WHEREAS, the Agency provides services that promote sporting events in Alachua County that strengthen and develop sporting events and programs that increase the tax; and

WHEREAS, the County finds that these services are in the best interest of its citizens by providing marketing or advertising designed to increase tourist-related business activities within the County; and

WHEREAS, §125.0104, Florida Statutes provides that funding may be provided from the tourist development tax for this purpose; and

WHEREAS, the parties hereto previously entered into an Amended and Restated Agreement October 10, 2006;

WHEREAS, the parties previously entered into the First Amendment to the Agreement on October 28, 2008;

NOW THEREFORE, the parties hereto agree: to further amend the restated and amended agreement dated October 10, 2006 as follows:

- A. Section 1, Term of the Agreement is amended in its entirety to read:
 - 1. <u>Term</u> This agreement shall commence on October 1, 2013 and continue through September 30, 2014 unless terminated as provided herein. The parties may extend the term of this agreement through an amendment approved by both parties.
- B. Section 3 Method of Payment is amended in its entirety to read:
 - A. The County agrees to provide funding not to exceed 16% of 99% of the Tourist Development Tax revenue dedicated to fund the Visitors and Convention Bureau received the previous fiscal year.

SAVE and EXCEPT as expressly amended herein, all other terms and provisions of the original agreement between the parties, dated October 10, 2006, shall be and remain in full force and effect.

Executive SummaryThe 2nd Amendment to the amended and restated agreement between Alachua County and the Gainesville Sports Organizing Committee extends the term of the contract until September 30, 2014.

Background

On October 10, 2006 the agreement between Alachua County and the Gainesville Sports Commission for the purposes of a providing funding to the sports commission as the official sports marketing agency for the County. On October 28, 2008 the parties entered into the first amendment of this contract for the purposes of extending the term until September 30, 2013.

With the recent restructuring by the Gainesville Sports Commission, a one year extension is appropriate to determine if longer contracts are warranted. Previous contracts have been for 5 year terms.
