#### **RE: CARES funding for Pandemic Learning Pods**

Dear Ms. Lieberman,

At the August 31<sup>st</sup> Board Meeting, CTAC voted to request that the Alachua County BoCC allocate CARES funding to support "Pandemic Learning Pods". Pandemic Learning Pods are intentional, small cohorts of children and responsible adults organized to support distance learning, socialization, and play. Pods provide an opportunity to minimize the risk for families who must return to work and thus require supervised environments for their children.

The Trust partnered with the Early Learning Coalition of Alachua County, Inc. and Kids Count in Alachua County, Inc. to provide space for 232 children, ages 5-13, who are at or below 200% of the Federal Poverty Level to have the opportunity to be supported in their distance learning experience until their parents deem it safe to return to school.

The Trust funded these Pandemic Learning Pods for the first 9 weeks of school for children who are participating in either Alachua Digital Academy or Alachua eSchool. CARES funding will allow this effort to continue for the second nine weeks of school. The total cost would be \$216,630.
