CLARIFICATIONS:

Pre-Bid Meeting Review 1/26/2021:

Please see the Recap provided by the department below as these topic were discussed during the visit Pre-Bid Meeting:

- 1) Can we patch the cracks in the pool and refinish? No, A complete Marcite restoration is required. Provide an alternate for Diamond Brite.
- 2) On the Revised BID Form, please make sure that the cost for the ALT 1 Diamond Brite is an added/deducted to the overall project instead of using marcite. Not the cost of the project if you were to use Diamond Brite. We will award Base Bid +/- ATL 1 if the county choose to go with the ALT 1 as an option.
- 2) Why a salt water conversion? Salt water conversion alternate is no longer required.
- 3) What is the desired completion date? Pool must be ready for use by May 31st, 2021. Provide cost for 60 day turn around and a 90 day turnaround from Date of Notice to Proceed.
- 4) Is the pool deck a complete restore? No, Pool deck to be cleaned, have cracks patched and a suitable pool deck paint applied.
- 5) Any deck repairs outside of the pool fenced area? No, Finished deck and concrete outside of fencing not part of this project.
- 6) How long has the pool been out of service? 6 years.

- 7) How will unforeseen code issues be addressed? Any unforeseen code issues that cannot be assumed in the bid will be submitted to the project coordinator as a change order.
- 8) Can the attic stock of perimeter tiles in the pump room be used? Yes, if there is enough. That will be the color selection for the replacement tiles.

The Bidder proposes and agrees, if this Bid is accepted, to contract with Alachua County, Florida, through the Board of County Commissioners, Gainesville, Florida, in the form of contract specified, to furnish all necessary materials, equipment, machinery, tools, apparatus, means of transportation, labor and service necessary to complete the work covered by the Bid and Contract Documents for: **BID: 21-965 Camp Cuscowilla Pool Renovations - Project # 8204102** to furnish the prescribed Performance and Payment Bond for not less than one hundred percent (100%) of the bid price; and to furnish the required evidence of the specified insurance.

The undersigned further agrees that in case of failure on his part to execute said contract within thirty (30) consecutive calendar days after written notice being given of award of contract, the certified or cashier's check or bid bond accompanying this bid, and money payable thereon, shall be paid into funds of the Alachua County Board of County Commissioners, Gainesville, Florida, as liquidated damages for such failure; otherwise, the check or bid bond accompanying this proposal shall be returned to the undersigned.

The undersigned agrees to commence work as set forth in the Notice to Proceed and to reach substantial completion within <u>120</u> working days from the date on which work commences with final completion within <u>15</u> calendar days thereafter.. If the Contractor fails to complete the work within the specified time, the Contractor agrees to pay the County \$250.00 per calendar day as liquidated damages for substantial completion and <u>\$250.00</u> per calendar day as liquidated damages for final completion.

The Bidder agrees to accept in full compensation for each item the prices named in the schedule incorporated herein and attached as "Bid Schedule". The Bidder understands that the quantities shown on the "Bid Schedule" are approximate only and subject to increase or decrease. Should they be increased or decreased, work will be performed at the unit price bid herein. Actual quantities will be determined upon completion of the work.
