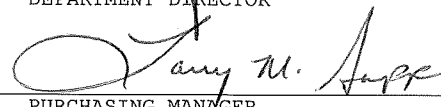
COMMENTS/EXPLANATIONS:

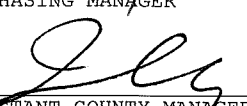
