### POTENTIAL FUTURE PHASING TO INCLUDE PUBLIC ACCESS:

The below estimates would require significant additional site assessment before finalization, and do not include significant restoration costs and potential mining remediation costs which may be required. Treatment of the widespread hydrilla in the mining pond waters would be needed prior to allowing public boat access, ranging from \$500-\$1000/acre/year). Costs estimated below are additive to TIER 1 costs above.

# <u>TIER 2</u> – LIMITED ACCESS BY APPOINTMENT ONLY (estimated with water access, no land improvements)

- \$35,000 for staff time
- \$7,000 for operating expenses
- \$15,000 for vehicle operation and maintenance
- \$10,000 boat ramp improvements
- \$25,000 ADA canoe kayak launch (1)

**TOTAL = \$87,000** (\$52,000 annual operating, \$35,000 initial water access improvements)

# <u>TIER 3</u> – OPEN SITE FOR REGULAR PUBLIC ACCESS (Estimate prepared by Alachua County Parks and Open Space, for recreational site management by Parks, with natural resource management support provided by Office of Land Conservation and Management)

- \$102,000 for two fulltime and one half-time employees
- \$253,475 for expenses including vehicle operation and replacement
- \$40,000 operating expenses (natural resource management)
- \$118,712 for new vehicles and equipment
- \$750,000 to \$1 million for site improvements including restrooms, fishing docks, trails, bridges, road improvements, fencing, and a small portable office

**TOTAL** = \$1,514,187 (\$395,475 annual operating, \$1,118,712 initial equipment, capital improvements)

### TIER 1 MANAGEMENT COST CALCULATONS

### Signage

Regulatory and Safety Signs = \$5,000 (WSPP)

### **Firebreak Construction**

Firebreak construction: 2 miles x \$210/mile plus mobilization= \$500 (WSPP)

Site Perimeter Fencing: 18,300 feet x \$5/linear foot=\$91,500 (WSPP)

Exotic Plant Control (does not include widespread non-native grass on spoil areas, or widespread

hydrilla in mining ponds) Year 1=\$2,500

Year 2-10=\$1,000

10 Year Total & Average=\$11,500 or \$1,150 per year (General Fund)

### Road/Trail/Firebreak Maintenance

Mowing: \$118/mile x 2 miles = \$236 x 4 times/year = \$944/year

Re-surfacing: \$1,000/year

10 Year Total = \$19,440 or \$1,944/year (General Fund)

#### Gates

Gates: 4 gates x \$250/gate: \$1,000

### **Prescribed Fire**

Not planned – allow spoil areas to transition to cedar dominated tree-cover

### **Historic Resources Maintenance:**

Asbury Cemetery Protection: \$3,000 (WSPP)

Annual Cemetery Maintenance (invasive tree maintenance): \$1000/year (General Fund)

### **Monitoring and security (in-house)**

192 hours of staff time plus equipment and supplies

Project oversight, contractor oversight, photo-points, inspections, record keeping

10 Year total = \$89,560 or \$8,956/year (**General Fund**)
