

# Community Redevelopment Grant, 2020-21 Alachua County and Rebuilding Together North Central Florida FINAL REPORT

Reporting Period (Grant Funds expended during these months): 9/1/2020 - 5/31/2021

#### SUMMARY:

Rebuilding Together North Central Florida (RTNCF) and the Community Weatherization Coalition (CWC) responded to the urgent community needs for safe, healthy housing and utility burden management during the early months of the COVID-19 pandemic by reimagining existing repair and energy efficiency programs to meet people where they were in safe and accessible ways. With funding from Alachua County's Community Redevelopment Grant (CRG), new infrastructures were built and implemented for Emergency Repairs and Do-It-Yourself (DIY) Home Energy Tune-Ups. Both programs were designed to provide immediate relief for residents facing health/safety hazards and/or high utility bills.

With that infrastructure in place, both programs launched in the summer of 2020. Funding was leveraged with other money available for Home Repair and Energy-Efficiency efforts via private and corporate donations, and public funds. Notably, 23,272.91 public dollars were leveraged toward this project, as were \$20,000 from Lowes and an additional \$10,000 in private funds. Several homes initially identified for Emergency Repairs were referred to RTNCF's Critical Repair Program, and were addressed with CAPP, HOME, and USDA dollars.

The Emergency Repair Program served 13 households (detailed below) and the DIY Energy Tune-Up Program served 15 (also detailed below). Response to the programs were extremely positive, and led to an effort by RTNCF and CWC to fund both programs beyond the grant period. Contracts are in the works to fund both programs via the City of Gainesville (through CDBG) and Alachua County (through CAPP). We envision the growth of both programs in the future, and are pitching both to current and potential funders to expand the programs to meet growing demand for these services locally.

- 12. A.S. NE Gainesville: Roof replacement
- 13. A.W. SW Gainesville: Leaking water heater replacement, ramp sealant
