Adoption of the Agenda

School Board Commissioner McNealy moved adoption of the agenda as printed. The motion carried 5-0.

Chair Chestnut recognized Jim Konish who presented comments to the Board.

Items For Discussion

<u>19-0334 Prairie View Elementary Update</u> Fiscal Consideration: N/A Recommended Action: Listen to an update on Prairie View Elementary.

Superintendent Karen Clarke stated that the current plan is that while Idylwild Elementary is being renovated the school children from Idylwild will be given instruction at Prairie View Elementary. This will allow the renovation timeframe to be shortened because the work could be done without having to schedule projects around an operating school.

Once Idylwild Elementary is complete the same process will be used for Williams Elementary. Once those two projects are complete there will be discussions for the use of Prairie View Elementary based on the progress of other school renovation projects.

Assistant Superintendent of Operations Paul White stated that the plan is to have construction at Idylwild Elementary starting in June of 2020. There is a tremendous cost savings by having the schools closed during construction.

Commissioner Cornell and Commissioner Wheeler presented comments.

<u>19-0331 After-School Public Transportation</u> Fiscal Consideration: N/A Recommended Action: Have a discussion on after-school public transportation.

Commissioner Cornell advised that a citizen group has approached the County with the concept of providing free RTS Bus service to all citizen 18 years and younger. The County Commission inquired if the School Board has had any involvement in the initiative and if they had any thoughts on the matter.

Superintendent Clarke advised that the School Board has not been approached regarding this matter. She advised that she could see issues with unaccompanied minors using the RTS system but there have not been any discussion on the matter. She advised that the School Board would be willing to discuss the matter.

Commissioner Wheeler, Commissioner Cornell, School Board Member Eileen Roy, School Board Chair Hyatt, School Board Member Dr. McNealy, and Commissioner Cornell presented comments.

<u>19-0330 Citizens Field Renovations Partnership</u> Fiscal Consideration: N/A Recommended Action: Have a discussion on Citizens Field Renovations Partnership.

Commissioner Wheeler advised that the City of Gainesville has contacted the County regarding a partnership in renovating the complex and inquired it the School Board has had in discussions on the matter.

Athletic Director Charley Wise advised that the School Board has not been contacted and that the School Board operates the facility through a lease with the City. The lease is set to expire in June of 2024. The School Board staff maintains the facility and is responsible for capital expenditures.

Commissioner Byerly advised that at last year's joint meeting the Boards discussed Impact Fees and he remembers there being an interest from the School Board but the Board wanted to wait till after the Tax Referendum was settled. Commissioner Byerly inquired if there is still an interest in pursuing the matter since the Tax Referendum has been passed and there are new members on the School Board.

School Board Chair Hyatt, School Board Member Certain, School Board Chair Hyatt, Commissioner Cornell, Commissioner Hutchinson, School Board Member Dr. McNealy, Commissioner Wheeler, and School Board Member Roy presented comments.

By consensus, the School Board stated that they would like to see a workshop conducted so that the matter can be discussed with all the necessary information available.
