Commissioner Cornell, Assistant County Attorney Bob Swain, Vice Chair Byerly, County Manager Lieberman, Commissioner Wheeler, Vice Chair Byerly, Chief Financial Officer Todd Hutchison, County Manager Lieberman, Commissioner Wheeler, Commissioner Byerly, and Commissioner Cornell presented comments.

# Commissioner Cornell moved the following: 2<sup>nd</sup> Chestnut

- That staff work with the Clerk of the Courts Office to develop a workable list of citizens that have severed their term but still have felony court fees and reside in Alachua County whether through the clerk's list, collection agency, or other sources.
- 2. Staff to bring back a presentation on what fees are being charged that the Board of County Commissioners has control over and what programs are funded by these revenues. (This includes the Room and Board fee.)
- 3. Direct staff to work with the Public Defender, 8<sup>th</sup> Judicial Circuit Bar Association, Florida Association of Counties, and the Florida Voting Rights Association to determine what other Counties are doing to address this issue including but not limited to amnesty programs, Judge Modified Sentences to restore voting rights. Work with stakeholders within the community.

Commissioner Wheeler, Kristin Young, Patricia Lee, Anthony Johnson, Public Defender Stacey Scott, Sherry Spencer, Assistant County Attorney Bob Swain, and County Manager Lieberman presented comments.

2. Climate Change Discussion 20-0062

**Recommended Action:** Adopt Climate Advisory Committee Resolution, authorize staff to initiate development of a Local Climate Plan and provide direction to staff on additional climate actions

Environmental Protection Department Director Chris Bird presented the above item.

Direct staff to develop a nine member citizen at large advisory committee with experience in climate change, resiliency, climate adaption or mitigation with three year appointments with 2 year and 1 year appointments initially to allow for annual appointments and authorize the Joint Committee to appoint these members that will then be ratified by both the City and County Commissions. If the City does not approve this then this item is to be brought back to the next Joint Meeting with nominations.
- 3. Direct County Staff to staff to the Climate Change Plan and the Climate Change Advisory Committee. The lead departments are resiliency, EPD, and Growth Management Departments.
- 4. Authorize staff to initiate and develop the Climate Change Plan.
- 5. Direct staff to bring back the Joint City County Water and Climate Policy Committee resolutions to update the County Green Purchasing Policy.

Jim Konish, Anthony Johnson, David Moritz, Tommy Baker, Nancy Darren, and Commissioner Cornell presented comments.

By consensus, the Board directed to add this matter to the March Policy Discussion.

The motion carried 4-0.

County Attorney Sylvia Torres presented the above item.

County Attorney Torres advised the Board the Charter Review Commission has one vacancy.
